President Kernighan and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances we recommended settlement in the sum of Six Hundred Forty-Five Thousand Dollars and No Cents (\$645,000.00) payable to Plaintiff Kayvan Sabeghi and his attorney Rachel Lederman.

This action arises from an incident on November 2, 2011, wherein Mr. Sabeghi was Injured during a confrontation with police near 17<sup>th</sup> and Broadway.

The Council authorized settlement of this case in Closed Session on Tuesday, December 10, 2013 (moved by Councilmember Gallo and seconded by Councilmember Kaplan - 7 Ayes, 0 Noes, 1 Absent – Councilmember Brooks).
