WHEREAS, the Honorable Mayor Jean Quan has appointed Nwamaka Agbo reappointed Jose Dorado as Mayoral Appointments and reappointed Melanie Shelby as a District 6 Representative upon the recommendation of Councilmember Desley Brooks and as a member of the Committee, to serve a one year term subject to confirmation by the City Council, now therefore, be it
