RECOMMENDATION

Staff recommends that the City Council as governing board of the Oakland Redevelopment Successor Agency ("ORSA"), adopt a resolution approving the submission of a Recognized Obligation Payment Schedule and ORSA Administrative Budget for January through June 2014 ("ROPS 13-14B") to the Oakland Oversight Board, Alameda County and the State (as required), with the revisions attached to this supplemental report

REASON FOR SUPPLEMENTAL

The purpose of this supplemental report is to add an obligation of excess Low and Moderate Income Housing Revenue Bonds for transfer to the City as Housing Successor to be used in the upcoming Notice of Funds Available (NOFA) Funds totaling \$219,783 have been freed up from the reserve for the MLK Jr Plaza Homes ownership project (ROPS line 404), which is no longer needed since the ten-year reserve period has expired

Additionally, there is a holdover of \$10 million in the Coliseum project area pertaining to the Bond Expenditure Agreement A separate item discussing the allocation of these funds to the Coliseum Transit Village project will be brought to Council in the next six months
