Dear President Kernighan and Members of the City Council:

At closed session on January 7, 2014, the City Council considered a proposed partial settlement with Syncora Guarantee, Inc. (f/k/a XL Capital Assurance, Inc.) ("Syncora") of City of Oakland v Ambac Financial Group, Inc., et al., San Francisco Superior Court Case No CGC-08-479241, City Attorney Matter No X03170.

The lawsuit alleges against Syncora and several other bond insurer defendants causes of action for fraud, breach of contract, and an antitrust conspiracy.

The settlement proposal was for the City to accept the payment from Wells Fargo of \$25,830.33, in exchange for dismissal with prejudice of the City's pending litigation

The City Council accepted the settlement proposal. Accordingly, we have prepared this Resolution authorizing and directing the City Attorney to enter into a settlement agreement consistent with the terms of the settlement proposal to resolve the Action, and we request that the City Council adopt the Resolution.
