RECOMMENDATION

Staff recommends that the City Council:

- 1) Adopt an Ordinance Amending the Salary Schedule of Ordinance No. 12187 C.M.S. ("Salary Ordinance") to create the classification of Fire Marshal (Non-Sworn); and
- 2) Approve a Resolution to Exempt From Civil Service the Classifications of Fire Marshal (Non-Sworn)

OUTCOME

The Salary Ordinance amendment and the resolution to exempt the classification of Fire Marshal (Non-Sworn) are proposed to implement Council authorization of funding for a civilian fire marshal position, pursuant to Resolution No. 84897 CMS approved on March 18, 2014.

The civilian fire marshal role serves as a division manager in the Fire Department. Staff recommends that the classification of Fire Marshal (Non-Sworn) be exempted from the provisions of Civil Service. If the exemption resolution is approved as presented, staff will present the recommendation to the Civil Service Board for final approval of exemption at its next meeting

BACKGROUND/LEGISLATIVE HISTORY

The Oakland Fire Department has identified the need to establish a Fire Marshal (Non-Sworn) position to oversee the Fire Prevention Division of the Fire Prevention and Support Services Bureau; the duties were performed by a variety of classifications in the past. This action is consistent with industry trends, as more fire marshals are rising through the civilian ranks than the sworn ranks It will also establish a career ladder and promotional opportunity for existing civilian staff.

Item: _____ Finance & Management Committee April 29, 2014 The City Charter, under Title IX Personnel Administration, section 902, lays out the conditions under which positions may be exempt from Civil Service Certain offices are specifically exempted (elected officials, City Administrator, etc.), but section 902(f) provides that other positions may be exempted if recommended by City Council and approved by the Civil Service Board.

ANALYSIS

The actions being proposed are recommended to implement Council action and to align the classification with other division manager classifications in terms of its bargaining unit and exemption from civil service.

PUBLIC OUTREACH

No public outreach was required.

COORDINATION

The Human Resources Management Department (HR) coordinated with the Fire Department to create the classification of Fire Marshal (Non-Sworn). Following the Council action proposed in this report, HR will present the Civil Service Board with the recommendation to exempt the classification from the provision of civil service.

COST SUMMARY/IMPLICATIONS

Partial funding for the civilian fire marshal position was authorized in previous budgets adopted by City Council with the remaining funding authorized by Resolution No 84897 CMS approved on March 18, 2014. Creating the appropriate title and salary schedule for the position has no new fiscal impact The proposed resolution exempting the classification has no fiscal impact.



RESOLUTION RECOMMENDING TO THE CIVIL SERVICE BOARD THE EXEMPTION OF THE CLASSIFICATION OF FIRE MARSHAL (NON-SWORN) FROM THE OPERATION OF THE CIVIL SERVICE

WHEREAS, the Oakland City Charter Section 902(f) requires that the City Council recommend positions for exemption from Civil Service prior to Civil Service Board approval of such exemption, and

WHEREAS, the Fire Marshal (Non-Sworn) classification is recommended for exemption from Civil Service due to its placement in the organization, lines of authority, reporting relationships within the department, as well as the duties, pay grade and independence of action; and

WHEREAS, incumbents in the Fire Marshal (Non-Sworn) positions serve as division managers and are expected to exercise considerable discretion in carrying out the City's mission for which there is a high consequence of error; now, therefore be it

RESOLVED: That the City Council of the City of Oakland hereby recommends to the Civil Service Board that the classification of Fire Marshal (Non-Sworn) be exempted from the requirements of civil service; and be it

FURTHER RESOLVED, that the Civil Service Board is hereby requested to approve such exemption.
