C457111) IN ACCORDANCE WITH PLANS AND SPECIFICATIONS FOR THE PROJECT AND WITH CONTRACTOR'S BID IN THE AMOUNT OF FIVE HUNDRED FORTY-FOUR THOUSAND THREE HUNDRED SEVENTY DOLLARS (\$544,370.00)

WHEREAS, on February 13, 2014, only one bid was received by the Office of the City Clerk of the City of Oakland for Sanitary Sewer Root Foaming FY 2013-14 (Project No. C457111); and

WHEREAS, a previous bid received for this project on November 14, 2013 was deemed non-responsive; and

WHEREAS, Duke's Root Control, Inc., a Contract Compliance certified contractor as a prime, is deemed the lowest responsive and responsible bidder for the project; and

WHEREAS, there are sufficient funds in the project budget for the work in the following project account:

 Sewer Service Fund (3100); Capital Projects - Sanitary Sewer Design Organization (92244); Sewers Account (57417); Project No. C457111; \$544,370.00; and these funds were specifically allocated for this project; this project will help reduce the amount of sanitary sewer maintenance requirement; and

WHEREAS, City Council finds and determines based on the representations set forth in the City Administrator's report accompanying this Resolution that the construction contract approved hereunder is temporary in nature; and
