REASON FOR SUPPLEMENTAL

The Public Works Department is presenting this supplemental report to provide an update on efforts to reduce illegal dumping in Oakland.

OUTCOME

This is an informational report to the Public Works Committee (PWC).

BACKGROUND/LEGISLATIVE HISTORY

There were Illegal Dumping Reports presented to the Public Works Committee on March 27, 2012 (file #11-0332), September 24, 2013 (file #12-0717), and March 25, 2014 (file #13-0401). This is a supplemental report to the aforementioned reports.

ANALYSIS

OPW Illegal Dumping Removal Program

As part of the FY 2013-15 Adopted Policy Budget, with the elimination of furlough days beginning July 1, 2013, Oakland Public Works Department (OPW) has been able to restore performance of illegal dumping removal to the standard of 85% completion rate in three (3) business days. The established Performance Measures and target achieved for illegal dumping removal for the past four (4) months is shown in Table 1 below.

In the first ten (10) months of FY 2013-14 the Keep Oakland Clean and Beautiful Division (KOCB) of OPW responded to 15,870 service requests to remove items illegally dumped on public property. This is a 14% increase in the number of requests from the previous year.

Include the type of debris, amount, and location in your report. Never touch hazardous or medical waste!

If You Witness Illegal Dumping

Please provide the following information to assist us in catching and prosecuting illegal dumpers:

- · Photo of the incident
- · License plate number and a description of any vehicles involved
- Description of the offender(s)
- · Description of items dumped
- · Time, date and location of incident you witnessed

Discourage Dumping on Your Property

- · Light outdoor areas around your home and property
- · Maintain clear sight lines so you can monitor from inside your home
- · Use surveillance cameras to record illegal dumping
- Define your property boundaries with plants, paving, short walls or fences
- Trim bushes to 36" high and tree limbs 7' from ground, cut weeds and maintaining a clean environment
- · Remove graffiti within 24-48 hours
