
This action arises out of the fatal shooting of Alan Blueford by an Oakland Police Department officer on May 5, 2012.

CITY OF OAKLAND, ET AL., UNITED STATES DISTRICT COURT, NORTHERN DISTRICT OF CALIFORNIA NO. C12-03791 WHO, CITY ATTORNEY'S FILE NO X03845 IN THE AMOUNT OF ONE HUNDRED TEN THOUSAND DOLLARS (\$110,000.00) (OAKLAND POLICE DEPARTMENT – EXCESSIVE FORCE)**

**WHEREAS**, Plaintiffs Adam Blueford and Jeralynn Blueford, successors-in-interest to Alan Blueford, allege he was fatally shot by an Oakland Police Department officer on May 5, 2012; and

**WHEREAS**, Plaintiffs Adam Blueford and Jeralynn Blueford filed the above-referenced action to recover monetary damages for their son's death; and

**WHEREAS**, The City Council has determined to compromise and settle Plaintiff Adam Blueford and Jeralynn Blueford's claim against it and Officer Miguel Masso for the sum of One Hundred Ten Thousand Dollars and No Cents (\$110,000.00); now, therefore, be it

**RESOLVED:** That the City Attorney is authorized and directed to compromise and settle the case of Adam Blueford, et al. v. City of Oakland, et al., United States District Court, Northern District of California Case No. C12-03791 WHO for a sum not to exceed One Hundred Ten Thousand Dollars and No Cents (\$110,000.00) payable by the City of Oakland; and be it

**FURTHER RESOLVED:** That the City Attorney is further authorized and directed to take whatever steps may be necessary to effect said settlement; and be it

**FURTHER RESOLVED:** That the sum of One Hundred Ten Thousand Dollars and No Cents (\$110,000.00) be paid to Jeralynn Brown Blueford.
