## OAKLAND CITY COUNCIL RESOLUTION No. 85015 C.M.S.

RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF LAWRENCE PAUL BRISCO, THOMAS CAMERON, AND MADDIE FLOOD TO THE CITIZEN'S POLICE REVIEW BOARD

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No. 12454 C.M.S., adopted November 12, 2002 (repealing Ordinance Nos. 11905 and 12102 C.M.S.) created the Oakland Citizen's Police Review Board to investigate and review certain complaints regarding conduct of Oakland police officers and park rangers, thereafter deliver timely advisory reports to the City Administrator regarding the facts of and recommended disposition of these complaints, as well as disciplinary recommendations if appropriate and additionally it may recommend policy changes to the Public Safety Committee regarding matters within its jurisdiction; and

WHEREAS, the Citizen's Police Review Board consists of nine members and three alternative members serving two-year staggered terms with no more than two consecutive terms; and

WHEREAS, the Honorable Mayor Jean Quan has appointed Lawrence Paul Brisco, Thomas Cameron, and Maddie Flood to each serve a two-year term on the Citizen's Police Review Board subject to confirmation by the City Council; now therefore be it

**RESOLVED,** that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of:

Lawrence Paul Brisco to serve a two-year term on the Citizen's Police Review Board beginning February 16, 2013 and ending February 15, 2015, filling the seat previously held by Denise Top.

Thomas Cameron to serve a two-year term on the Citizen's Police Review Board beginning February 16, 2014 and ending February 15, 2016, filling the seat previously held by Larissa Casillas.

Maddie Flood to serve as a youth alternate for a two-year term on the Citizen's Police Review Board beginning February 16, 2013 and ending February 15, 2015, filling the seat previously held by Elizabeth Diaz.
