## RECOMMENDATION

Staff recommends that the City Council adopts a resolution authorizing the City Administrator to give the Oakland Private Industry Council, Inc. a one-time administrative support grant not-to-exceed \$50,000.

## EXECUTIVE SUMMARY

The Oakland Private Industry Council (OPIC) has requested support for its operations in the amount of \$50,000. The City Administrator requests City Council authorization to give the organization a one-time administrative support grant from the General Fund not-to-exceed \$50,000.

## OUTCOME

With the \$50,000 grant, the Oakland PIC will be able to stabilize its financial position and perform overdue improvements on its facility in downtown Oakland.

## BACKGROUND/LEGISLATIVE HISTORY

The Oakland Private Industry Council (OPIC) is a long-standing public benefit corporation that has served tens of thousands of Oakland residents. Due to funding reductions, the agency has experienced financial challenges. The one-time grant is in recognition of OPIC's valuable services for Oakland residents.




