RECOMMENDATION

Staff recommends that the City Council adopt a resolution authorizing the City Administrator to:

- 1. Enter into grant agreements with agencies selected under the City of Oakland's 2014-2015 Request For Proposals (RFP) process for the Permanent Access To Housing (PATH) strategy in an amount of \$1,101,022 with an option to extend for an additional two years without returning to Council;
- Allocate a general purpose fund match up to \$133,000 to East Oakland Community Project (EOCP) for the City's Families In Transition (FIT) program, funded by the U.S. Department of Housing & Urban Development (HUD) Supportive Housing Program (SHP) grant;
- 3. Allocate a general purpose fund match up to \$52,750 to EOCP for the city's Matilda Cleveland Transitional Housing Program (MCTHP), funded under HUD/SHP;
- Allocate Community Development Block Grant (CDBG) funds up to \$23,064 to cover lease costs at the Matilda Cleveland Transitional Housing facility for the Fiscal Year (FY) 2014-2015;
- 5. Accept and appropriate funding up to \$268,943 awarded to the City of Oakland by Alameda County and enter into a grant agreement with Bay Area Community Services, Inc., for shelter services from July 1, 2014 to June 30, 2015;
- 6. Allocate funds up to \$91,000 to cover mortgage costs at EOCP for the Crossroads Shelter for the FY 2014-2015 and enter into an agreement with EOCP in the amount of \$126,504 for the operation of the shelter;
- 7. Allocate funds up to \$40,020 to fulfill the City's annual obligation to the Alameda County Everyone Home Strategy and Alameda County Homeless Management Information System (HMIS);
- 8. Allocate match funds \$17,103 for the Abode Services Supportive Housing Program grant

to increase Supportive Housing Services in Oakland through the Oakland PATH Rehousing Initiative (OPRI);

- 9. Enter into a grant agreement with Alameda County Community Food Bank in the amount of \$100,000 for the City's Hunger Program from July 1, 2014 to June 30, 2015, and accept any additional funds up to \$50,000 donated to the hunger program and amend the agreement with the food bank without returning to Council; and
- Specify the funding sources of grant funds for a Memorandum of Understanding and grant agreement with Alameda County Behavioral Health Care Services (BHCS) Agency for PATH activities in the amount of \$200,000 as authorized by Resolution No. 84927 C.M.S.

EXECUTIVE SUMMARY

Staff seeks Oakland City Council approval to execute FY 2014-2015 Permanent Access to Housing (PATH) Strategy three-year grant agreements with the second and third years of each grant agreement contingent upon available funding. Upon close-out of FY 2013-2014 contracts, staff will determine available balances for additional funding to be released through a Request For Proposals (RFP) process to increase housing and housing services to the homeless and near homeless in Oakland.

The City receives over \$3 million in U.S. Housing & Urban Development (HUD) Supportive Housing Program (SHP) funding. Each SHP grant requires a Grantee match. Staff has identified match funds and seeks approval to allocate these match resources to the proposed SHP providers as mandated by HUD under the SHP grants.

The City participates in the Alameda County EveryOne Home Homeless Management Information System (HMIS) planning and implementation as well as County-wide application collaboration for the HUD Continuum of Care funding. This collaborative effort brings in approximately \$27 million into Alameda County to house and serve the homeless. As part of the collaborative, each participating jurisdiction must provide financial support for the operation of the EveryOne Home HMIS and EveryOne Home HUD Continuum of Care application process. The City's annual commitment to the countywide process is approximately \$51,000. To date, staff has identified \$40,020 and will make every effort to locate the additional \$10,980 before December 2014.

Staff also seeks approval to execute contracts and allocations for FY 2014-2017 as indicated under the Cost Summary portion of this report for miscellaneous programs and activities administered by the Human Services Department, Community Housing Services Division. The second and third year of PATH allocations are contingent upon adequate performance and available funding.

Total allocations for recommended actions are for not more than \$1,101,022. Any additional allocations are contingent upon service and fund sources negotiated between the City and Alameda County Offices for PATH services.

OUTCOME

Approval of this report and resolution will ensure level, if not greater success compared to FY 2010-2011 outcomes referenced below, for Oakland programs serving the homeless and near homeless individuals.

Performance

During the 2013-2014 program/fiscal year:

PATH Strategy:

- 2,532 homeless or near homeless persons were served through Oakland's PATH Strategy¹.
- Of the 2,532 served with shelter, rapid rehousing, rental assistance and other supportive services, 912 obtained or maintained permanent housing and 247 obtained or maintained transitional housing.

Supportive Housing Programs:

- 308 singles and families received transitional housing and services, assisting them into stable living situations.
- 186 of the 308 singles and families served exited the SHP into permanent housing.

Hunger Programs:

Approximately 5,500 households were recipients of the City's Hunger/Food
Distribution program, yielding over 317,000 meals through food distributions and
special events.

BACKGROUND/LEGISLATIVE HISTORY

PATH Strategy

On May 8, 2007, Oakland City Council accepted and approved the Oakland Permanent Access to Housing (PATH) Strategy, a companion to the Alameda Countywide EveryOne Home Plan to end homelessness in Oakland and Alameda County. ¹ PATH totals presented here include services provided through PATH grant agreements, OPRI (Oakland PATH Rehousing Initiative), Homeless Mobile Outreach, and Oakland Temporary Winter Shelter.

The overarching strategy articulated in PATH and EveryOne Home is to shift the approach to homelessness away from managing it and towards solving it. Key elements of this shift include transitioning from emergency shelter and services towards the acquisition, development and operation of permanent affordable and supportive housing, and the restructuring and refinement of homelessness prevention activities, including new initiatives to prevent people from being discharged from publicly funded systems into homelessness, and to ensure that people who do become homeless are rehoused as rapidly as possible.

The PATH Strategy took the place of the City of Oakland's outdated Oakland Citywide Continuum of Care Plan. PATH and EveryOne Home grew out of the realization by community leaders, City and County staff, providers and consumers that, while Alameda County and its cities have a long history of innovative and successful programs to address the housing needs of people who are homeless and/or those with special needs, simply continuing with a "continuum of care" approach was not going to result in ending homelessness. The Plan also grew out of an emerging understanding that the human and financial costs of homelessness are enormous. The costs of not solving this problem are great and borne by everyone: by people who are in crisis because they have no place to live, and by the entire community in the form of diminished community well-being, including the financial burden of paying for emergency and social services that generally do not end homelessness for those served.

PATH and EveryOne Home are intended to guide City policies and how resources are used to end homelessness. The PATH Strategy employs a Housing First approach to ending homelessness. The Housing First approach is commonly implemented through four primary stages:

- 1. Crisis Intervention and Short-Term Stabilization
- 2. Screening, Intake and Needs Assessment
- 3. Provision of Housing Resources
- Provision of Case Management

In order to implement these four stages, the PATH Strategy focuses on both housing development activities to provide needed housing resources, and realignment of the service delivery system to support the transition to a Housing First approach.

PATH Strategy implementation priorities are summarized as follows:

- 1. Housing Resources
- 2. Rapid Re-Housing Services
- Preventing Homelessness

The first full year of Oakland's PATH Strategy was administered in FY 2008-2009, as approved by Oakland Resolution No. 81494 C.M.S., passed on July 15, 2008.

Baseline funding for PATH currently is through the Emergency Solutions Grant (ESG), a Federal formula grant annually awarded by the U. S. Department of Housing & Community Development; Community Development Block Grant; Oakland General Purpose Fund; Alameda County Housing and Community Development Department, and private donors. Partnering with key Alameda County agencies (ACA) to increase the capacity of PATH funds leverage ACA funds and better serve the homeless of Oakland prove to be promising for FY 2014-2015.

Supportive Housing Programs

The City of Oakland has annually received awards under the Federal Supportive Housing Program competitive Super NOFA (Notice of Funding Availability) process to fund the City's Families in Transition (FIT) program, the Matilda Cleveland Transitional Housing Program (MCTHP), the Housing Fast Support Network (HFSN) and the Oakland Homeless Youth Housing Collaboration (OHYHC). These programs provide housing to singles and families for up to 24 months with support services to assist them in reaching a sustainable level of self-sufficiency and, ultimately stable housing.

HUD's Supportive Housing Program requires a local funding match:

- FIT- City provides match funds from its Homeless GPF annual allocation in the amount of \$133,000;
- MCTHP- City provides match funds from its Community Promotions Program for Service Organizations (CPPSO) annual allocation in the amount of \$52,750;
- HFSN- Alameda County provides a grant match to the City in the amount of \$268,943;
- OHYHC- The local match requirement is provided by the network of contracted agencies: East Oakland Community Project, Covenant House, and First Place For Youth;
- The East Oakland Community Project (EOCP) is the contracted agency under the FIT & MCTHP program. Bay Area Community Services, Inc. is the contracted agency under the HFSN program.

Lease Payment

The Matilda Cleveland Transitional Housing Program is located at 8314 MacArthur Boulevard, a 14 unit apartment complex with office space, leased by the City from Hope Housing, Inc. at a rate of \$3,000/month or \$36,000/year; \$10,184 of the \$36,000 lease expense is covered by the annual SHP grant funds for the MCTHP. The balance (\$23,064) of the annual lease cost is generally covered by reprogrammed funds identified by Community Housing Services (CHS) staff.

Hunger Program

From the City of Oakland's Adopted Annual Budget, an annual allocation of \$100,000 from its General Purpose Fund is allocated to the Hunger Program for brown bag food distributions to low-income households. Alameda County Community Food Bank provides the bulk of food supplies for each distribution under the City's Hunger Program, at a discounted rate. Staff annually seeks authorization to execute an Agreement between the City and Alameda County Community Food Bank, in the amount of \$100,000. Staff and community groups remain active in fundraising for the Hunger Program, and staff requests to apply any additional funds received through donations to the Food Bank agreement.

EveryOne Home/Homeless Count

The City participates in the Alameda County EveryOne Home Homeless Management Information System (HMIS) planning and implementation as well as county-wide application collaboration for the HUD Continuum of Care funding. This collaborative application effort brings in approximately \$27 million into Alameda County to house and serve the homeless. Approximately \$8 million directly benefits non-profit agencies in Oakland. As part of the collaborative, each participating jurisdiction must provide financial support for the operation of the EveryOne Home HMIS and EveryOne Home HUD Continuum of Care Application process. The City's annual commitment is approximately \$51,000. Staff currently has identified \$40,020 of that amount and will work to make available an additional \$10,980 by the end of the calendar year.

ANALYSIS

Oakland City Council authorization of staff recommendations included in this Council report and resolution supports objectives of the Oakland PATH Strategy, to increase housing opportunities for homeless persons, prevent homelessness and other housing crisis, deliver flexible services to support stability and independence of the City's homeless and near homeless populations.

Further, City Council's authorization to enter into funding arrangements and/or collaborations with Alameda County Social Services, Alameda County Housing & Community Development and/or Alameda County Behavioral Health Care Services supports the increased success of the Oakland PATH Strategy, potentially resulting in a substantial increase in resources that will benefit the City's homeless and near homeless populations through rapid rehousing, homeless prevention, shelter diversion, benefits and employment assistance and other needed services to assist people living on the streets into safe, stable, and healthy housing condition.

General Purpose Fund allocations to the City's Matilda Cleveland Transitional Housing Program (MCTHP) and Families in Transition (FIT) programs, and Alameda County Social Services funds awarded to the City for the operation of the Homeless Families Support Network (HFSN), will be used to satisfy Federal grantee match requirements for each of these Supportive Housing Program (SHP) grants. As a result, Oakland will continue to receive \$3,034,358 in Federal SHP funds, leveraged with \$185,750 in City General Purpose Funds and \$268,943in Alameda County funds granted to the City, to deliver transitional housing and support services to eligible singles and families striving to prevent their households from becoming homeless or returning to a state of homelessness, as each individual and family works towards the ultimate goal of obtaining stable housing and the resources necessary to maintain housing.

PUBLIC OUTREACH/INTEREST

This report did not require public outreach.

COORDINATION

This item required coordination with the Alameda County Housing and Community Development Agency (HCD) and the Alameda County Behavioral Health Care Services Agency; the report and resolution have been approved by the Office of the City Attorney and the Budget Office

COST SUMMARY/IMPLICATIONS

Recommendations of this report are to fund up to the following amounts to the agencies listed below for the City's PATH Strategy, Supportive Housing Program match requirements, Hunger Program, annual lease cost for the Matilda Cleveland Transitional Housing program, mortgage for the East Oakland Community Project, and the City's annual commitment to the Alameda County EveryOne Home Plan and Homeless Management Information System.

As mentioned earlier in this report, Community Housing Services is in partnership with Alameda County Offices (Behavioral Health Care Services, Social Services Agency, and Housing & Community Development) to explore the potential of maximizing Oakland PATH and County funds by coordinating housing, service and fund sources to best serve and house the homeless in Oakland. The possibilities of this partnership will enable the City to make additional funds available for rapid rehousing assistance and services annually.

The Union Pacific Railroad has made annual contributions benefitting the City's Community Clean Up Corps program as part of the PATH Homeless Mobile Outreach Program. City expects a donation of approximately \$10,000 for the FY 2014-2015 program year. This award is generally made in January.

PATH allocations for the FY 2015-2016 and FY 2016-2017 will be contingent upon availability of City of Oakland, Alameda County, and other fund sources. For FY 2014-2015:

- 7. ALLOCATE FUNDS UP TO \$40,020 TO FULFILL THE CITY'S ANNUAL OBLIGATION TO THE ALAMEDA COUNTY EVERYONE HOME STRATEGY AND ALAMEDA COUNTY HOMELESS MANAGEMENT INFORMATION SYSTEM (HMIS);
- 8. ALLOCATE MATCH FUNDS \$17,103 FOR THE ABODE SERVICES SUPPORTIVE HOUSING PROGRAM GRANT TO INCREASE SUPPORTIVE HOUSING SERVICES IN OAKLAND THROUGH THE OAKLAND PATH REHOUSING INITIATIVE (OPRI);
- 9. ENTER INTO A GRANT AGREEMENT WITH ALAMEDA COUNTY COMMUNITY FOOD BANK IN THE AMOUNT OF \$100,000 FOR THE CITY'S HUNGER PROGRAM FROM JULY 1 2014 TO JUNE 30, 2015, AND ACCEPT

- ANY ADDITIONAL FUNDS UP TO \$50,000 DONATED TO THE HUNGER PROGRAM AND AMEND THE AGREEMENT WITH THE FOOD BANK WITHOUT RETURNING TO COUNCIL; AND
- 10. SPECIFY THE FUNDING SOURCES OF GRANT FUNDS FOR A MEMORANDUM OF UNDERSTANDING AND GRANT AGREEMENT WITH ALAMEDA COUNTY BEHAVIORAL HEALTH CARE SERVICES (BHCS) AGENCY FOR PATH ACTIVITIES IN THE AMOUNT OF \$200,000 AS AUTHORIZED BY RESOLUTION NO 84927 C.M.S.

WHEREAS, Oakland City Council Resolution No. 79923 C.M.S., passed on May 30, 2006 authorizes the development and implementation of the City of Oakland's Permanent Access To Housing (PATH) Strategy to end homelessness; and

WHEREAS, the PATH Strategy is a companion to the Alameda County-wide EveryOne Home Plan, a three tiered system to ending homelessness in the next ten years, by combining housing and service priorities for homeless, persons with HIV/AIDS, and persons with mental health care needs; and

WHEREAS, The City of Oakland released a request for proposals for permanent supportive housing and homeless services under the City of Oakland's Permanent Access To Housing (PATH) Strategy, funding contingent upon General Purpose Fund allocations, and Community Development Block Grant funds allocated for CHS programs and staff; and

WHEREAS, Community Housing Services (CHS) staff along with a consultant reviewed renewal applications submitted along with performance outcome reports covering the previous performance period, agencies performed at levels ranging from "Effective" to "Exceeds Expectation" and all 2013-2014 PATH contractors, including Homeless Mobile Outreach contractors are recommended for 2014-2015 renewal of PATH funding; and

WHEREAS, said renewal contracts are recommended contingent upon final fund availability totals to cover recommended PATH awards in the amount of \$1,101,022 and Community Housing Services personnel costs to be covered by Emergency Solutions Grant (ESG-HUD) funds, Emergency Housing Program (General Purpose) funds, Homeless Mobile Outreach Program (General Purpose and Public Works) funds, Community Development Block Grant fund homeless set-aside, Community Promotions Program for Service Organizations (CPPSO-General Purpose), and reprogrammed fund balances; and

WHEREAS, staff has identified funds in the amount of \$1,101,022 for the continued provision of housing with wrap-around services under the City of Oakland's PATH Strategy, which includes the Homeless Mobile Outreach Program (HMOP); and

WHEREAS, there is an annual allocation of \$60,000 from General Purpose Funds and an annual allocation of \$60,000 from the City of Oakland's Department of Public Works to support the HMOP for an annual funding total of \$120,000; and

WHEREAS, the City of Oakland is a recipient of SHP grants from HUD to support the City's Matilda Cleveland Transitional Housing Program in an amount of \$264,765, Families In Transition Program in an amount of \$249,815, Housing Fast Support Network in an amount of \$1,864,465, and the Oakland Homeless Youth Housing Collaborative in the amount of \$713,095; and grantee match funding (which are listed in Table 2 below) are required to support services and operations at the Matilda Cleveland Transitional Housing Program, the Families In Transition Program and the Homeless Families Support Network Program; and

WHEREAS, HUD awarded \$905,884 for the OPRI/SHP administered by Abode Services Inc., and the City has committed to provide match funding in the amount of \$17,103 for the 2014-2015 program year; and

WHEREAS, the City does not have funds budgeted in the baseline to cover lease costs mandated by City Council for the Matilda Cleveland Transitional Housing Program and staff has identified \$23,064 to cover lease costs of \$36,000 per year not covered by the MCTHP SHP grant referenced above; and

WHEREAS, the City contributes annually to the Alameda countywide EveryOne Home Plan for the countywide Homeless Management Information System (HMIS) and joint SuperNOFA application which brings in over \$25 million to Alameda County for homeless housing and services, \$8 million benefitting homeless services programs in Oakland, and \$3,092,140 directly to the City of Oakland to support and fund various City Supportive Housing Programs, and the City has identified funds in the amount of \$40,020 to contribute to the annual countywide plan for FY 2014- 2015; and

WHEREAS, an annual allocation of \$100,000 is made from the City's General purpose fund to support the City's Hunger Program (Food Distribution program) serving more than 3,500 low-income Oakland residents annually, and Alameda County Community Food Bank (ACCFB) has been selected to provide said services for 2014-2015 and staff seeks authorization to enter into Agreement with ACCFB for these services from July 1, 2014 through June 30, 2015; and

WHEREAS, the City of Oakland has identified \$91,000 to cover the EOCP mortgage for FY 2014-2015; now, therefore, be it

RESOLVED: That the City Council authorizes the allocation of available HUD Emergency Solutions Grant, in the amount of \$561,836; and be it

FURTHER RESOLVED: That the City Administrator is authorized to allocate funds for the Abode Services Program to support the Oakland PATH Rehousing Initiative in an amount of \$17,103; and be it

FURTHER RESOLVED: That the City Administrator is authorized to allocate funds to Alameda County Behavioral Health Care in the amount of \$200,000 as authorized by resolution No. 84927 C.M.S.; and be it

FURTHER RESOLVED: That the City Administrator is authorized to allocate funds and to enter into grant agreements with the following agencies, in the amounts specified in the Table 1 below for FY 2014-2015:

FURTHER RESOLVED: That the Agreements authorized under this resolution shall be reviewed as to form and legality by the Office of the City Attorney and copies will be filed in the Office of the City Clerk.
