RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CLAIM OF GERALD AND CHRISTINA GRAY CITY ATTORNEY'S CLAIM NO. C29678, IN THE AMOUNT OF THREE HUNDRED SEVENTY TWO THOUSAND, TWO HUNDRED TWENTY-TWO DOLLARS AND THIRTEEN CENTS (\$372,222.13) (PUBLIC WORKS AGENCY- SEWER OVERFLOW)

WHEREAS, the claimant alleges that on July 16, 2013, the City sewer main backed up and sewage flooded the property located at 7895 Sterling Drive; and

WHEREAS, the claimant(s) filed the above entitled claim seeking payment for said damages; and

WHEREAS, the City of Oakland has determined that settlement in this amount, without an admission of liability, is in the best interest of the City; now therefore, be it

RESOLVED: That the City Attorney is authorized and directed to settle the claim of Gerald and Christina Gray and John S. Claassen, Attorney of Record, our file C29678, for the total sum of Three Hundred Seventy-Two Thousand Two Hundred Twenty-Two Dollars and Thirteen Cents (\$372,222.13), payable as Two Hundred Seventy-Seven Thousand Dollars and No Cents (\$277,000.00) to Gerald and Christina Gray and John S. Claassen, their Attorney of Record and Ninety-Five Thousand Two Hundred Twenty-Two Dollars and Thirteen Cents (\$95,222.13) to Balfour Property Restoration; and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement; and be it

FURTHER RESOLVED: That the sum of Two Hundred Seventy Seven Thousand Dollars and No Cents (\$277,000.00), be made payable to Gerald and Christina Gray and John S. Claassen, Attorney of Record and Ninety-Five Thousand Two Hundred Twenty-Two Dollars and Thirteen Cents (\$95,222.13) to Balfour Property Restoration.
