#### INTRODUCED BY COUNCILMEMBER REBECCA KAPLAN

#### RESOLUTION RE-ALLOCATING THE GRANT OF \$500.00 FROM COUNCILMEMBER KAPLAN'S PAY-GO FUNDS FROM GOOD HOPE BAPTIST CHURCH TO GALATIANS BAPTIST CHURCH'S YOUTH GROUP FOR TRAVEL AND MEAL EXPENSES TO DISNEYLAND, CA.

**RESOLVED**, that the City Council authorizes the grant of \$500.00 from Councilmember Rebecca Kaplan's Pay-Go funds to the Galatians Baptist Church's Youth Group for travel to Disneyland, CA; and, be it

**FURTHER RESOLVED**, that the City Administrator is authorized to execute an appropriate grant agreement with the Galatians Baptist Church's Youth Group for the above purpose, subject to approval as to form and legality by the City Attorney.
