OAKLAND V. AMBAC FINANCIAL GROUP, INC., ET AL., SAN FRANCISCO SUPERIOR COURT CASE NO. CGC-08-479241, AUTHORIZING ACCEPTANCE OF PAYMENT FROM FINANCIAL SECURITY ASSURANCE, INC. AND ASSURED GUARANTY, INC. OF \$1,000, IN EXCHANGE FOR DISMISSAL OF THE LAWSUIT BY THE

CITY

Dear President Kernighan and Members of the City Council:

At closed session on July 29, 2014, the City Council considered a proposed partial settlement with of <u>City of Oakland v. Ambac Financial Group, Inc., et al.</u>, San Francisco Superior Court Case No. CGC-08-479241, City Attorney Matter No. X03170.

The lawsuit alleges against Financial Security Assurance, Inc. (n/k/a Assured Guaranty Municipal Corp.) and Assured Guaranty Corp. ("FSA/Assured"), and several other bond insurer defendants causes of action for fraud, breach of contract, and an antitrust conspiracy.

The settlement proposal was for the City to accept the payment of \$1,000 from FSA/Assured in exchange for dismissal with prejudice of the City's pending litigation.

The City Council accepted the settlement proposal. Accordingly, we have prepared this Resolution authorizing and directing the City Attorney to enter into a settlement agreement consistent with the terms of the settlement proposal to resolve the Action, and we request that the City Council adopt the Resolution.
