President Kernighan and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances settlement is recommended in the sum of Eighty-Seven Thousand Five Hundred Dollars and No Cents (\$87,500.00) payable to Plaintiff Erenst Edel and his attorney Brian L. Larsen.

This action arises from an incident on June 19, 2012, wherein Mr. Edel was injured when he tripped and fell on a defective sidewalk near a bus stop on College Avenue near Broadway. Mr. Edel sustained serious injuries in that fall.

The Council authorized settlement of this case in Closed Session on Tuesday, July 29, 2014 (moved by Councilmember Reid and seconded by Councilmember Kalb - 7 Ayes, 1 Absent).

**RESOLVED:** That the City Attorney is authorized and directed to compromise and settle the case of <u>Erenst Edel v. City of Oakland</u>, City Attorney's File No. 29351, for the sum of Eighty-Seven Thousand Five Hundred Dollars and No Cents (\$87,500.00); and be it

**FURTHER RESOLVED:** That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement; and be it

**FURTHER RESOLVED:** That the sum of Eighty-Seven Thousand Five Hundred Dollars and No Cents (\$87,500.00) be payable to Plaintiff Erenst Edel and his attorney Brian L. Larsen.
