RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF D. BLAKE SPEARS AND REAPPOINTMENTS OF KAREN SMULEVITZ AND SYLVIA STADMIRE AS MEMBERS OF THE COMMISSION ON AGING

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Ordinance No 9921 C.M.S., adopted May 13, 1980 and amended in 1985 by Ordinance No. 10561 C.M.S., in 1989 by Ordinance 11081 C.M.S., and in 1995 by Ordinance No 11773, establishes the Commission on Aging to advocate for the elderly and serve as an Advisory Board to the Department on Aging; and

WHEREAS, the Commission on Aging consists of eleven (11) members serving not more than two consecutive three year terms; and

WHEREAS, the Honorable Mayor Jean Quan has appointed D. Blake Spears and reappointed Karen Smulevitz and Sylvia Stadmire to serve three-year terms subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of:

D. Blake Spears to the Commission on Aging for a three-year term beginning September 2, 2012 and ending September 1, 2015, filling the seat previously held by Ramon Williams; and be it

FURTHER RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's reappointments of:


Karen Smulevitz to the Commission on Aging for a second three-year term beginning November 24, 2013 and ending November 23, 2016.
