C11-03846 NC, CITY ATTORNEY'S FILE NO. 28414 IN THE AMOUNT OF THREE HUNDRED FORTY-EIGHT THOUSAND DOLLARS (\$348,000.00) (PUBLIC WORKS DEPARTMENT/OFFICE OF PARKS AND RECREATION – AMERICAN DISABILITIES ACT (ADA) ACCESS)

WHEREAS, Plaintiff Donna White alleges she was denied legally compliant disabled access at Woodminster Amphitheater on October 10, 2010 and October 9, 2011; and

WHEREAS, Plaintiff Donna White filed the above-referenced action to recover monetary damages and attorneys' fees for denial of legally compliant disabled access to her; and

WHEREAS, the City has determined to compromise and settle Plaintiff Donna White's claim against it for the sum of Three Hundred Forty-eight Thousand Dollars and No Cents (\$348,000.00); and

WHEREAS, the City has agreed to perform the injunctive relief pursuant to agreement of the parties to improve disabled access to Woodminster Amphitheater; now, therefore, be it

**RESOLVED:** That the City Attorney is authorized and directed to compromise and settle the case of <u>Donna White v. City of Oakland</u>, United States District Court, Northern District of California Case No. C11-03846 NC for a sum not to exceed Three Hundred Forty-eight Thousand Dollars and No Cents (\$348,000.00) payable by the City of Oakland, of which sum Twenty-three Thousand Dollars and No Cents (\$23,000.00) constitutes monetary damages, and the remaining Three Hundred Twenty-five Thousand Dollars and No Cents (\$325,000.00) constitutes attorneys' fees; and be it

**FURTHER RESOLVED:** That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement; and be it

**FURTHER RESOLVED:** That the sum of Three Hundred Forty-eight Thousand Dollars and No Cents (\$348,000.00) be paid to Paul Rein in Trust for Donna White.
