Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled claim for the sum of Seven Thousand Nine Hundred Twenty Dollars and Sixty Cents (\$7,920.60) payable to California State Automobile Association as subrogee for Sharon Collier.
