INTRODUCED BY COUNCIL PRESIDENT PATRICIA KERNIGHAN

RESOLUTION AUTHORIZING COUNCIL PRESIDENT PATRICIA KERNIGHAN AS DELEGATE OR IN THE ALTERNATIVE COUNCILMEMBER NOEL GALLO AS ALTERNATE DELEGATE TO TRAVEL TO AUSTIN, TEXAS TO ATTEND THE 2014 NATIONAL LEAGUE OF CITIES ANNUAL CONFERENCE AND EXPO FROM NOVEMBER 19-22, 2014

WHEREAS, Council President Patricia Kernighan, the City of Oakland's delegate to the National League of Cities Annual Meeting taking place in Austin Texas on November 22, 2014, wishes to represent the City of Oakland at the 2013 National League of Cities Annual Conference and Expo in Austin, Texas from November 19-22, 2014; and

WHEREAS, Councilmember Noel Gallo, the City of Oakland's alternate delegate to the National League of Cities Annual Meeting wishes to attend the National League of Cities Annual Conference in the event that Council President Kernighan is unable to do so; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation is \$503 (\$403 air; \$100 ground), of lodging is \$600, of per diem is \$168, of conference registration fees is \$435, and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, Council President Kernighan seeks Council approval of the
aforementioned estimated costs to travel to Austin, Texas to attend the 2014
National League of Cities Annual Conference and Expo, November 19-22, 2014;
now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized.
