

WHEREAS, the Honorable Mayor Jean Quan has appointed Cathy Leonard to serve a three-year term as District 1 Representative and appointed Derrick C. Bulls to serve a three-year term as District 7 Representative, subject to confirmation by the City Council; now therefore be it
