WHEREAS, the claimant filed the above entitled claim seeking payment for said damages, and

WHEREAS, the City of Oakland has determined that settlement in this amount, without an admission of liability, is in the best interest of the City; now therefore, be it

RESOLVED: That the City Attorney is authorized and directed to settle the claim of Liberty Mutual Insurance Company as subrogee for Valerie Dzubur, our file number C30166, in the amount of Six Thousand Seven Hundred Twenty Four Dollars and One Cent (\$6,724.01); and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps may be necessary to effect said settlement; and be it

FURTHER RESOLVED: That the sum of Six Thousand Seven Hundred Twenty Four Dollars and One Cent (\$6,724.01), be made payable to Liberty Mutual Insurance Company as subrogee for Valerie Dzubur.

President Kernighan and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled claim for the sum of Six Thousand Seven Hundred Twenty Four Dollars and One Cent (\$6,724.01), made payable to Liberty Mutual Insurance Company as subrogee for Valerie Dzubur.

This action arises out of a July 2, 2014 incident in which a City fire truck collided with a parked vehicle. Settlement of this matter is recommended to avoid the risk of litigation.

The Council authorized settlement of this case in Closed Session on Thursday, October 9, 2014 (moved by Councilmember Gallo and seconded by Councilmember Reid – 6 Ayes, 2 Absent – Councilmembers Brooks and Gibson McElhaney).
