Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled claim for the sum of Two Million Dollars and no Cents (\$2,000,000.00), payable to The Law Offices of Gwilliam, Ivary, Chiosso, Cavalli & Brewer, In Trust For Nancy Lee, Monica Lee, and Samantha Lee.

This action arises out of Allen Lee's fatal bicycle accident on Grizzly Peak Boulevard on September 24, 2011. Plaintiffs allege that a crack in the road caused the accident and constituted was a Dangerous Condition of Public Property under § 835 of California's Government Code.

The Council authorized settlement of this case in Closed Session on Tuesday, October 7, 2014 (moved by Gibson McElhaney and seconded by Councilmember Schaaf – 8 Ayes).
