## **RECOMMENDATION**

Staff recommends that the City Council approve a resolution to appropriate undesignated General Purpose Fund (GPF) balance as follows:

Resolution Amending the City of Oakland's FY 2014-15 Midcycle Budget, which was Adopted Pursuant to Resolution No. 85085 C.M.S. on July 1, 2014, and further amended by Resolution No. 85281 C.M.S. on November 18, 2014 to appropriate FY 2014-15 GPF Expenditures in an Amount not to Exceed \$1,185,155 from undesignated fund balance for Oakland Parks and Recreation (OPR) Reserve for Youth Program (\$800,000) and Oakland Public Library (OPL) Reserve (\$385,155)

# **REASON FOR SUPPLEMENTAL**

The purpose of this supplemental report is to provide additional information and analysis of the request to reserve funds for OPL and OPR and address the Committee's concern regarding the use of one-time revenues for ongoing expenditures pursuant to the Consolidated Fiscal Policy. A revised resolution has been prepared for this Special City Council meeting.

# **SUMMARY**

Approval of this resolution will amend the FY 2014-15 Midcycle Budget to fund OPR (\$800,000) and OPL (\$385,155) reserves with one-time revenues. Setting aside these reserve funds now will enable OPR to plan for the spring and summer programs in a timely manner. The OPL reserve provides additional funds that will be used to help balance anticipated shortfalls in the FY 2015-17 OPL budget. Staff will return to Council to request appropriation of these reserve funds for specific programmatic maintenance and enhancements. It is anticipated that these funds will be primarily utilized on temporary part-time positions. However, any

## <u>ANALYSIS</u>

#### Oakland Parks and Recreation

Approval of this item will set aside \$800,000 in a reserve for OPR. Anticipated use of these funds is two-fold:

- 1. To address the anticipated cost of implementing the voter-approved local minimum wage law (Measure FF). Staff's analysis of the impact to City employees shows that the impact on the higher minimum wage is primarily on the Recreation Aide, PT, Recreation Attendant I/II, PT and Recreation Leader I/II, PT classifications. The anticipated cost for both the increased minimum wage and sick leave provision is approximately \$250,000 for the period of March through June 2015, but could be less if impacted part-time employees are hired after March. The funds are essential to cover the additional program cost without increasing fees.
- 2. To increase the number of after school and summer employees hired to operate youth programs, particularly in low income areas of the City. The balance of \$550,000 will be used to hire additional Recreation Leader I/II, PT positions to serve Recreation Centers through-out the City, but primarily in low income areas. Increased staff would support after school and summer programming such as homework assistance, visual and performing arts, sports, fitness, cooking, and drama. Reserving these funds now is necessary in order to finalize the Spring and Summer programs of 2015, for which the catalog is currently being finalized.

#### Oakland Public Library

The action reserves an additional \$385,155 for anticipated library shortfalls in the FY 2015-17 budget. FY 2013-14 unaudited expenditures exceeded revenues by nearly \$2.4 million, which resulted in the use of available fund balance within the Measure Q Fund (2241). This use of fund balance was anticipated and discussed during FY 2014-15 Midcycle Budget deliberations (File # 13-0540-1, Midcycle Budget Questions, Response #3). The remaining Measure Q fund balance is expected to be needed te cover a similar operating shortfall in FY 2014-15. At Midcycle, \$500,000 was appropriated to OPL as a contingency for potential future funding deficiencies due to continued expenditure growth outpacing revenue growth within the Measure Q Fund. As part of the appropriations resulting due to Q4 R&E report in November 2014, \$114,845 was appropriated as additional contingency funds for the Library. Adding \$385,155 would bring the Library reserve to a total of \$1 million to help address the projected shortage of Measure Q funds beginning Jnly 1, 2015. To the extend funds can be set aside now, balancing the Measure Q Fund and sustaining Library operations will be more easily addressed during the FY 2015-17 budget deliberations.

**RESOLUTION AMENDING THE CITY OF OAKLAND'S FY 2014-15 MIDCYCLE BUDGET, WHICH WAS ADOPTED PURSUANT** то **RESOLUTION NO. 85085 C.M.S. ON JULY 1, 2014 AND AMENDED BY** RESOLUTION 85281 C.M.S. ON NOVEMBER 18, 2014 то GENERAL APPROPRIATE FY. 2014-15 PURPOSE FUND **EXPENDITURES IN AN AMOUNT NOT TO EXCEED \$1,185,155 FROM** UNDESGNATED FUND BALANCE FOR OAKLAND PARKS AND **RECREATION RESERVE FOR YOUTH PROGRAM (\$800,000) AND** OAKLAND PUBLIC LIBRARY RESERVE (\$385,155)

WHEREAS, on July 1, 2014, the City Council adopted the FY 2014-15 Midcycle Policy Budget (Resolution 85085 C.M.S.), which authorized appropriations of \$493,709,824 in FY 2014-15 in the General Purpose Fund; and

WHEREAS, the FY 2013-14 Fourth Quarter Revenue and Expenditure Report projects that there is undesignated and un-appropriated fund balance in the General Purpose Fund comprised of one-time revenue in the amount equal to \$11.25 million; and

WHEREAS, on November 18, 2014, the City Council adopted the FY 2014-15 Midcycle Policy Budget (Resolution 85281 C.M.S.), which authorized appropriations of \$7,246,887 in FY 2014-15 in the General Purpose Fund; and

WHEREAS, the Oakland Parks and Recreation Reserve and Library Reserve Fund are comprised of one-time revenue; and

WHEREAS, the appropriation and uses of funds deposited in Oakland Parks and Recreation Reserve and Library Reserve Fund are subject to the limitations and requirements relating to the use of one-time revenue for ongoing expenditures pursuant to the Consolidated Fiscal Policy; and

WHEREAS, the Administration has identified additional expenditures that will require appropriations to continue to provide current services and fulfill the policy directives established by the City Council; therefore be it **RESOLVED:** That the Oakland City Council, hereby amends the Fiscal Year 2014-15 budget to appropriate additional General Purpose Fund one-time revenue in an amount not to exceed \$1,185,155 for deposit in the Oakland Parks and Recreation Reserve (\$800,000) and Library Reserve (\$385,155) for future appropriation.
