Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled claim for the sum of Forty Thousand Dollars and No Cents (\$40,000.00), to be paid to Yolanda Huang, Esq., In Trust For Rickey Clay. Ms. Huang is Mr. Clay's attorney.

This action arises out of plaintiff Rickey Clay's arrest on May 4, 2012, following his being escorted out of the Police Department's open house. Plaintiff alleges his constitutional rights were violated and brings claims under 42 U.S.C. § 1983.

The Council authorized settlement of this case in Closed Session on Tuesday, January 6, 2015 (moved by Councilmember Kalb and seconded by Councilmember Gibson McElhaney – 8 Ayes).
