#### RECOMMENDATION

Staff recommends that the City Council:

Approve a Resolution Authorizing the City Administrator to approve Industrial Disability Retirements for local safety members of the California Public Employees' Retirement System ("CalPERS" or "PERS") and authorizing the City Administrator to apply for Industrial Disability Retirements on their behalf.

### **OUTCOME**

Approval of the recommendation will establish the authority of the City Administrator or his designee to approve industrial disability retirements for local safety members of the CalPERS and authorizes the City Administrator or designee to apply for Industrial Disability Retirements on their behalf.

#### BACKGROUND/LEGISLATIVE HISTORY

The City of Oakland PERS Safety Disability Retirement Committee meets on a monthly basis to make their recommendation to the City Administrator regarding the approval or denial of the Industrial Disability Retirement Applications submitted by sworn members of the Oakland Police Department and Oakland Fire Department. The Committee's recommendation requires the completion of a document ("Determination of Disability Letter") to be sent to CaPERS regarding the approval or denial. The authority to approve PERS safety disability retirements has been previously established by City Council Resolution No. 77353 C.M.S. to be the City [Manager], Assistant City [Manager], and/or the [Director of Personnel]. These City officer's titles were changed to now be City Administrator, Assistant City Administrator (City Council Resolution No. 78225 C.M.S.) and Director of Human Resources Management.

# **ANALYSIS**

Approval of this resolution updates the authority designation to grant Industrial Disability Retirements to local safety members to the specification required by CalPERS.

INTRODUCED BY COUNCILMEMBER\_\_\_\_

A RESOLUTION AUTHORIZING THE CITY MANAGER, THE ASSISTANT CITY MANAGER AND THE DIRECTOR OF PERSONNEL TO APPROVE SAFETY DISABILITY RETIREMENTS FOR MEMBERS OF THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM (PERS).

WHEREAS, the City of Oakland is a contracting agency of the Public Employees' Retirement System;

WHEREAS, the Public Employees' Retirement Law requires that a contracting agency determine whether an employee of such agency in employment in which he is classified as a local safety member is disabled for purposes of the Public Employees' Retirement Law and whether such disability is "industrial" within the meaning of such law;

WHEREAS, City Council has determined upon legal advice that it may delegate authority to make such determinations to the City Manager, Assistant City Manager and Director of Personnel pursuant to section 21173 of the Government Code;

NOW, THEREFORE, BE IT RESOLVED: That the City Council hereby delegates to the City Manager, Assistant City Manager and Director of Personnel authority to make determinations on behalf of the City of Oakland of disability and whether such disability is industrial and to certify such determinations and all other necessary information to the Public Employees' Retirement System; and

BE IT FURTHER RESOLVED that the City Manager, Assistant City Manager and the Director of Personnel are each authorized to make applications on behalf of the City of Oakland for disability retirement of all employees and to initiate requests for reinstatement of such employees who are retired for disability.

A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO APPROVE INDUSTRIAL DISABILITY RETIREMENTS FOR LOCAL SAFETY MEMBERS OF THE CALIFORNIA PUBLIC EMPLOYEES' RETIREMENT SYSTEM AND AUTHORIZING THE CITY ADMINISTRATOR TO APPLY FOR INDUSTRIAL DISABILITY RETIREMENTS ON THEIR BEHALF

**WHEREAS**, the City of Oakland is a contracting agency of the California Public Employees' Retirement System ("CalPERS"); and

WHEREAS, CalPERS requires that the City Council make a determination of whether a safety member employed by the City of Oakland is eligible for CalPERS industrial disability retirement in accordance with the provisions of California Government Code sections 21150, et seq.; and

WHEREAS, CalPERS authorizes the City Council to apply for industrial disability retirement benefits on behalf of local safety members in accordance with California Government Code section 21152; and

WHEREAS, the City Council is authorized to delegate its authority and duties with regard to CalPERS local safety disability retirements pursuant to California Government Code sections 21152 and 21173; and

WHEREAS, on July 30, 2002, the City Council passed Resolution No. 77353 C.M.S., delegating its authority with regard to CalPERS local safety disability retirements to the City Manager, Assistant City Manager and Director of Personnel; and

WHEREAS, the City no longer has a City Manager, Assistant City Manager or Director of Personnel inasmuch as the City Manager has been replaced with a City Administrator in accordance with the 2004 amendment of Article V of the City Charter; and the Director of Personnel has been replaced with a Director of Human Resources Management with the 2014 enactment of Oakland Municipal Code section 2.29.110; and

**WHEREAS,** the City Council now desires to delegate its authority with regard to CalPERS local safety disability retirements to the City Administrator, or his or her designee; now therefore be it

**RESOLVED:** that pursuant to California Government Code section 21173, the City Council hereby delegates to the City Administrator, or his or her designee, the

authority to make determinations of whether local safety members are eligible for CalPERS industrial disability retirement; and be it

**FURTHER RESOLVED,** that pursuant to California Government Code section 21152, the City Council hereby delegates to the City Administrator, or his or her designee, the authority to apply for industrial disability retirement on behalf of local safety members.
