#### **RECOMMENDATION**

Staff recommends that the City Council adopt a resolution authorizing the City Administrator to

- 1) Amend the 2014-2017 Permanent Access To Housing (PATH) grant agreement with Abode Services to add \$47,948 for housing retention services;
- 2) Amend the 2014-2017 PATH grant agreement with East Oakland Community Project (EOCP) to add \$55,163 for housing retention services;
- 3) Enter into a grant agreement in an amount not to exceed \$27,980 with Alameda County as fiscal agent for EveryOne Home (EOH) for the Alameda Countywide EOH Plan;
- 4) Enter into a grant agreement with the Society of St. Vincent De Paul (SVDP) for the provision of warming center services for the period of November 17, 2014 through April 15, 2015; and

Authorizing a contribution from the General Purpose Fund in an amount equivalent to the Department's Central Services Overhead for fiscal years 2014-2015, 2015-2016 and 2016-2017 in an estimated total amount of \$421,564.

#### **EXECUTIVE SUMMARY**

A resolution has been prepared that provides fiscal reconciliation of prior grants legislation and allocates funding to several programs related to the execution of the PATH strategy to end homelessness.

Staff received City Council approval on July 15, 2014 per Resolution No. 85112 C.M.S. to execute a number of 2014-2017 PATH Strategy three-year grant agreements. Primary funding for homeless programs and services is derived from Federal sources, including the formula

grants Community Development Block Grant (CDBG), Housing for Persons with AIDS (HOPWA), and the Emergency Solutions Grant (ESG). At the time the PATH grants legislation was executed, the Federal budget was not yet finalized due to the effects of sequestration. The local grants allocations were in accordance with the best available estimates of anticipated revenues from Federal sources, but the funds were not in hand at the time, nor were the Federal award amounts finalized. Subsequently, federal appropriations were finalized and received by the City and other prior year unspent program balances were identified and made available for programming. The accompanying resolution authorizes the allocation of these funds to several 2014-2017 grants in order to reconcile prior budget shortfalls from the original grants legislation.

Allocations in this category include the Abode Services grant agreements, two EOCP programs for housing-related services to homeless families, the annual EOH allocation, the allocation of ESG administration funds for staff costs and the allocation to EOCP to cover mortgage costs.

The City's annual commitment to the countywide EOH, including the pro rata share of the Homeless Management Information System (HMIS) and jurisdictional share of EOH support, is approximately \$51,000. HMIS functions are administered through Alameda County Housing and Community Development Department (ACHCD). On July 15, 2014, in the original grants legislation, \$40,020 was identified for this purpose. At this time the balance of \$10,980 has been identified to fulfill the City's annual commitment to EveryOne Home. In addition, the bi-annual HUD mandated county-wide homeless count will occar in January 2015, and by allocating up to \$17,000 to EOH for the count, the City of Oakland will obtain city-specific homeless data.

Staff also recommends the reprograming of the \$30,000 previously allocated to a grant agreement with Dignity Housing West to a grant agreement for the same amount with the Society of SVDP for the provision of warming center services for the period of November 17, 2014 through April 15, 2015. Dignity Housing West had faellity readiness issues and withdrew from participation as a warming center and SVDP has stepped forward as an alternate warming center provider.

#### **OUTCOME**

Approval of this report and resolution will ensure level, if not greater success compared to 2012-2013 outcomes referenced below, for Oakland programs serving the homeless and near homeless individuals.

#### Supportive Housing Programs

- 491 singles and families received transitional housing and services, assisting them into stable living situations:
- 209 (81.64%) of the 256 singles and families served exited the SHP into permanent housing.

#### **Hunger Programs**

Approximately 5,500 households were recipients of the City's Hunger/Food
Distribution program, yielding over 317,000 meals through food distributions and

#### **BACKGROUND/LEGISLATIVE HISTORY**

#### PATH Strategy

On May 8, 2007, City Council accepted and approved the Oakland PATH Strategy, a companion to the Alameda Countywide EOH Plan to end homelessness in Oakland and Alameda County. The first full year of Oakland's PATH Strategy was administered in 2008-2009, as approved by Oakland City Council Resolution No. 81494 C.M.S., passed on July 15, 2008. The PATH Strategy gradually shifted the City of Oakland's Plan to End Homelessness from a continuum of care homeless service delivery system to a "housing-first" model to end homelessness. Biannually, a PATH Strategy grants Request for Proposals (RFP) is issued in the spring, based on anticipated revenues from Federal and local grants. The RFP is followed in June by an annual grants allocation recommendation report to City Council and a grants reconciliation report in December.

Baseline funding for PATH currently is through Emergency Solutions Grant (ESG), a Federal formula grant annually awarded by the United States Department of Housing & Community Development, CDBG, Oakland General Purpose Fund, ACHCD and private donors. Partnering with Alameda County agencies to increase the capacity of PATH funds by leveraging Affordable Care Act funding is also a key PATH Strategy element for fiscal year 2014-2015.

### Winter Shelter and Warming Center Operations

Staff also recommends the reprograming of the \$30,000 previously allocated to a grant agreement with Dignity Housing West to a grant agreement for the same amount with the Society of SVDP for the provision of warming center services for the period of November 17, 2014 through April 15, 2015. Dignity Housing West had facility readiness issues and withdrew from participation as a warming center and SVDP has stepped forward as an alternate warming center provider.

On November 5, 2014, the Oakland City Council authorized a **Regional Inclement Weather Response System** using a limited, lifeline quantity of every night winter shelter beds for vulnerable populations and warming centers to be opened as needed during inclement weather events for the general homeless population, as well as a rapid re-housing approach that aims at placing clients into permanent housing. Under this strategy, Oakland funding is used to finance shelter and warming center accommodations. Alameda County general fund contributions will be used to fund outreach and initial rapid re-housing resources.

For the first seven weeks of operations (Nov. 15 – Dec. 31) there were 17 inclement weather events that triggered opening of the warming centers. The warming centers were used by homeless persons who were, in part, medically vulnerable, as identified and referred by City and County outreach teams. The average age of participants was over 51 years and mahy had disabilities. During one particular day of heavy rains on December 11, 2014 shelters and warming centers remained open during the day to offer respite from the elements.

Warming center composite census data for both St. Vincent de Paul and the Henry Robinson Center for the period of November 15, 2014 through December 31, 2014 is as follows:

Given the fact that 17 of the budgeted 40 days of warming center operations have been used within the first 30 days, it is possible that the program will run out before the end of the season if above average rainfall continues. In such a case, HSD may need to return to Council for additional funding to sustain warming center operations for this fiscal year.

#### **COST SUMMARY/IMPLICATIONS**

The recommendation of this report is to allocate funds up to the amounts listed below for the City's PATH Strategy, for continued provision of supportive services at Abode Services and EOCP, provide case management to the Shelter Plus Care families formally housed at the Henry Robinson Multi Service Center, amual mortgage cost for the Crossroads shelter and the City's contribution to the Alameda County EOH Plan and the 2015 Homeless Count.

#### 3. FISCAL IMPACT:

The accompanying resolution requests a contribution from the General Purpose Fund in the amount equivalent to the Department's Central Services Overhead charges for various grants supporting the Community Housing Division (as noted with the authorizing resolution in the chart below). The amount of the General Purpose Fund's contribution is estimated to be \$136,086 for fiscal year 2014-2015, and estimated to be \$142,739 per year for fiscal years 2015-2016 and 2016-2017, for a total contribution of \$421,564. Staff is requesting a contribution due to the low rate of administrative expenditures allowance – capped at 3% to 3.5% - afforded by the Federal grants.

#### SUSTAINABLE OPPORTUNITIES

**Economic:** As noted in the report, all funds identified this report are for the purpose of providing housing and services to the homeless to eliminate and prevent homelessness. Such outcomes are achieved through rapid rehousing assistance, homelessness prevention, transitional housing, shelter services, homeless encampment services, outreach and the like.

**Environmental:** The provision of housing for at-risk and homeless persons is intended to address the environmental degradation caused by homeless families and individuals precariously housed or living on the streets.



AUTHORIZING A CONTRIBUTION FROM THE GENERAL PURPOSE FUND IN AN AMOUNT EQUIVALENT TO THE DEPARTMENT'S CENTRAL SERVICES OVERHEAD FOR FISCAL YEARS 2014-2015, 2015-2016 AND 2016-2017 IN AN ESTIMATED TOTAL AMOUNT OF \$421,564

WHEREAS, staff received Oakland City Council approval on July 15, 2014 per Resolution No. 85112 C.M.S. to execute a number of 2014-2017 PATH Strategy three-year grant agreements; and

WHEREAS, at the time the PATH grants legislation was executed, the federal budget was not yet finalized, due to the effects of sequestration; and

WHEREAS, as a result of delays in the federal budget, several grants were reduced in funding, pending federal funds availability; and

WHEREAS, federal appropriations have been finalized and received by the City, and other prior year unspent program balances have been identified and made available for programming; and

WHEREAS, allocation of these funds to several 2014-2017 grants will reconcile prior budget shortfalls from the original grants legislation; and

WHEREAS, funds in the amount of \$30,000 previously allocated to Dignity Housing West for warming center services were not awarded to that agency due to facility issues; and

WHEREAS, the Society of SVDP has stepped forward to provide warming center services and staff recommends SVDP for provision of these services; and
