<b>FURTHER RESOLVED:</b> That Councilmember Anne Campbell Washington is hereby appointed as an elected member of the Oakland City Council on the Chabot Space and Science Center Joint Powers Authority Board of Directors, to fill the seat formerly held by Councilmember Libby Schaaf, for the term beginning January 2015, and ending January 2017.
