WHEREAS, on July 25, 2006 the Oakland City Council approved the Joint Powers Authority ("JPA") creating the Youth Ventures Joint Powers Authority; and

WHEREAS, the seats previously held by prior Councilmembers Kernighan and Schaaf are now vacant due to intervening changes in elected office holders; and

WHEREAS, the City Council's Rules of Procedure (Resolution No. 82580 C.M.S) state that "the President of the Council shall recommend appointments to the regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; now, therefore, be it
