WHEREAS, the City Council's Rules of Procedure (Resolution NO 82580 C.M S) provide that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to the confirmation by the Council", now, therefore, be it

RESOLVED: That Mayor Libby Schaaf is hereby appointed as an elected member of the Oakland City Council on the Chabot Space and Science Center Joint Powers Authority Board of Directors for the term beginning January, 2015 and expiring January, 2018, and be it

FURTHER RESOLVED: That Councilmember Anne Campbell Washington is hereby appointed as an elected member of the Oakland City Council on the Chabot Space and Science Center Joint Powers Authority Board of Directors, to fill the seat formerly held by Councilmember Libby Schaaf, for the term beginning January 2015, and ending January 2017.
