Pursuant to Section 401 of the City Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances settlement is recommended in the sum of Ten Thousand Dollars and No Cents (\$10,000.00) payable to Plaintiff Clifton Raines and his attorneys The Law Office of Michael Wohlstadter.

This action arises from an incident on October 15, 2012, wherein Mr. Raines tripped and fell in a privately owned drain line clean-out box located in the public sidewalk adjacent to 6720 San Pablo Avenue in Oakland, a Sherwin Williams paint store. Mr. Raines suffered broken bones in his feet, requiring medical treatment.

The City Council authorized settlement of this case in Closed Session on Tuesday, April 21, 2015.
