President Gibson McElhaney and Members of the City Council

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing partial compromise and settlement of the above-entitled claim for the sum of Thirty Thousand Five Hundred Seventy-Nine Dollars and one cent Dollars and One Cent (\$30,579.01), made payable to Ellen Reier, and authorization for the expenditure of up to \$28,800 for rental housing for Ellen Reier for up to one year or the sale of her home, whichever occurs first, paid on a monthly basis at the rate of \$2,400.00 per month. Additionally, the City Administrator has expended \$13,200.00 in temporary housing costs to date which will be reimbursed.

This action arises out of a sewer flood damage incident on February 18, 2015 which caused damage to claimant's property at 1200 Westview Drive. The flooding was caused by a failed City sewer main. Partial settlement of this matter is recommended to avoid the risk of litigation.

The Council authorized settlement of this case in Closed Session on Tuesday, March 31, 2015 (moved by Councilmember Kaplan and seconded by Councilmember Gallo – 5 Ayes, 2 Absent – Councilmembers Kalb and Reid, 1 Abstention – Councilmember Guillen).
