**RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT
OF RAVINDER SINGH, COLLEEN BROWN AND THE
REAPPOINTMENT OF JAY ASHFORD, DON LINK, AND JOHN
GARVEY AS MEMBERS OF THE COMMUNITY POLICING
ADVISORY BOARD**

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Resolution No. 72727 C.M.S., adopted June 11, 1996 and amended by Resolution No. 73916 C.M.S., adopted November 4, 1997, which changed the body's status from a Task Force to a Board, establishes that the Community Policing Advisory Board shall oversee, monitor and report at least twice yearly and provide recommendations on community policing to the Mayor, City Council, City Manager, and director of Police Services; and

WHEREAS, the Community Policing Advisory Board consists of fifteen (15) members, all Oakland residents, serving three-year terms, three appointed by the Mayor, one by each Councilmember, one by the Oakland Housing Authority, one by the Oakland Unified School District Board, and two by the Home Alert Steering Committee; and

WHEREAS, the Honorable Mayor Libby Schaaf has appointed Ravinder Singh to serve a three-year term as District 4 Representative and appointed Colleen Brown to serve a three-year term as District 6 Representative, subject to confirmation by the City Council; and

WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Jay Ashford to serve a three-year term as Mayor's Representative, reappointed Don Link to serve a three-year term as Mayor's Representative, and reappointed John Garvey to serve a three-year term as Mayor's Representative, subject to confirmation by the City Council; now therefore be it

RESOLVED, That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of:

Ravinder Singh to the Community Policing Advisory Board to serve a three-year term beginning March 25, 2015 and ending March 24, 2018, filling the seat previously held by Krista Gulbranse.

Colleen Brown to the Community Policing Advisory Board to serve a three-year term beginning March 25, 2014 and ending March 24, 2017, filling the seat previously held by John Nichols; and be it

RESOLVED, That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's reappointment of:

Jay Ashford to the Community Policing Advisory Board to serve a three-year term beginning March 25, 2015 and ending March 24, 2018, filling the seat previously held by Jay Ashford.

Don Link to the Community Policing Advisory Board to serve a three-year term beginning March 25, 2015 and ending March 24, 2018, filling the seat previously held by Don Link.

John Garvey to the Community Policing Advisory Board to serve a three-year term beginning March 25, 2015 and ending March 24, 2018, filling the seat previously held by John Garvey.



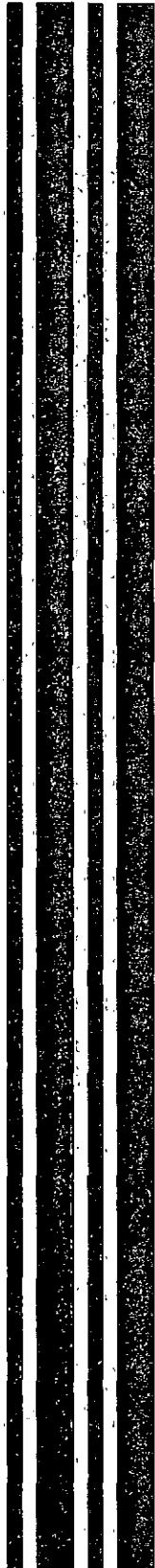

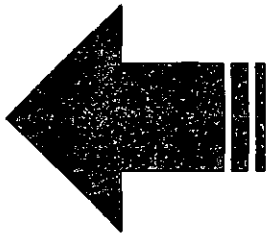

RESOLUTION APPOINTING JODY NUNEZ, TONY MARKS-BLOCK, CURTIS FLEMMING, JENNIFER MADDEN, REBECCA ALVARADO, MELANIE SHELBY, KEVIN MCPHERSON, LETITIA HENDERSON, AND GARRY SCOTT AS MEMBERS OF THE PUBLIC SAFETY AND SERVICES VIOLENCE PREVENTION OVERSIGHT COMMISSION

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, the 2014 Oakland Public Safety and Services Violence Prevention Act, also known as the Safety and Services Act or Measure Z, adopted by the voters of Oakland, November 4, 2014 in the General Municipal Election creates the Public Safety and Services Violence Prevention Oversight Commission to evaluate, inquire, and review the administration, coordination, and evaluation of strategies and practices mandated by the 2014 Oakland Public Safety and Services Violence Prevention Act; and

WHEREAS, the 2014 Oakland Public Safety and Services Violence Prevention Act specifies that the Public Safety and Services Violence Prevention Oversight Commission shall consist of nine (9) members with the Mayor and each City Council member recommending one name for appointment on the Commission, with all Commission members being appointed by the Mayor and confirmed by the City Council in accordance with City Charter Section 601; and

WHEREAS, the 2014 Oakland Public Safety and Services Violence Prevention Act specifies that at least two (2) members will have experience working with service-eligible populations, two (2) members will reflect the service-eligible populations, and two (2) members will have professional law enforcement or criminal justice background while all other members will have general experience in criminal justice, public health, social services, research and evaluation, finance, audits, and/or public policy; and

WHEREAS, the appointments listed below are subject to the adoption of the Ordinance Establishing the Membership Terms and Quorum Requirement for the Public Safety and Services Violence Prevention Oversight Commission; and

WHEREAS, the Honorable Mayor Libby Schaaf has appointed the individuals listed below to serve the specified terms subject to confirmation by the City Council; now therefore be it

RESOLVED: That pursuant to City Charter Section 601, the City Council hereby confirms the Mayor's following appointments to the Public Safety and Services Violence Prevention Oversight Commission:

Jody Nunez, Mayoral appointment upon the recommendation of Councilmember Dan Kalb for District 1 Representative, serving as a law enforcement/criminal justice representative, to serve the term beginning April 21, 2015 and ending April 20, 2016, filling a vacant seat.

Tony Marks-Block, Mayoral appointment upon the recommendation of Councilmember Abel Guillen as the District 2 Representative, serving as a 'reflects service-eligible population' representative, to serve the term beginning April 21, 2015 and ending April 20, 2017, filling a vacant seat.

Curtis Flemming, Mayoral appointment upon the recommendation of Council President Lynette Gibson-McElhaney as the District 3 Representative, serving as a 'working with service-eligible population' representative, to serve the term April 21, 2015, and ending April 20, 2016, filling a vacant seat.

Jennifer Madden, Mayoral appointment upon the recommendation of Councilmember Annie Campbell-Washington as the District 4 Representative, serving as a law enforcement/criminal justice representative, to serve the term beginning April 21, 2015 and ending April 20, 2017, filling a vacant seat.

Rebecca Alvarado, Mayoral appointment upon the recommendation of Councilmember Noel Gallo as the District 5 Representative, serving as a general member representative, to serve the term April 21, 2015 and ending April 20, 2016, filling a vacant seat.

Melanie Shelby, Mayoral appointment upon the recommendation of Councilmember Desley Brooks as the District 6 Representative, serving as a general member representative, to serve the term beginning April 21, 2015 and ending April 20, 2017, filling a vacant seat.

Kevin McPherson, Mayoral appointment upon the recommendation of Councilmember Larry Reid as the District 7 Representative, serving as a law enforcement/criminal justice representative, to serve the term April 21, 2015 and ending April 20, 2016, filling a vacant seat.


