RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO 1) ENTER INTO AN AGREEMENT WITH ALAMEDA COUNTY SOCIAL SERVICE AGENCY (SSA) TO ACCEPT AND APPROPRIATE \$286,110 EACH YEAR FOR FISCAL YEARS 2015-2016 AND 2016-2017 FOR THE HENRY J. ROBINSON MULTI SERVICE CENTER, 2) ENTER INTO GRANT AGREEMENTS WITH BAY AREA COMMUNITY SERVICES IN THE AMOUNT OF \$268,943 FOR THE PROVISION OF TRANSITIONAL HOUSING AND SUPPORT SERVICES AT THE HENRY J. ROBINSON MULTI SERVICE CENTER EACH YEAR FOR FISCAL YEARS 2015-2016 AND 2016-2017, IF CITY RECIEVES SSA FUNDING, AND 3) AUTHORIZING A CONTRIBUTION FROM THE GENERAL PURPOSE FUND IN THE AMOUNT EQUIVALENT TO THE DEPARTMENT'S CENTRAL SERVICES OVERHEAD IN AN ESTIMATED AMOUNT OF \$759 EACH YEAR FOR FISCAL YEARS 2015-2016 AND 2016-2017

WHEREAS, the Alameda County Social Services Agency (SSA) has partnered with the City since 1991 to provide program match funds to the Housing and Urban Development's (HUD) Transitional Housing Program (THP) that provides support services and transitional housing to homeless single adults; and

WHEREAS, the HUD THP program located at the Henry J. Robinson Multi Service Center has used the SSA funds to satisfy the HUD match requirement for its grant; and

WHEREAS, the County SSA grant is a one year funding cycle and City staff expects that the City of Oakland will receive the same amounts for Fiscal Years 2015-2016 and 2016-2017, and seeks authorization to enter into an agreement with Alameda County SSA to accept and appropriate those funds as they become available; and

WHEREAS, the City desires to execute grant agreements with Bay Area Community Services in the amount of \$268,943 to provide transitional housing and support services to homeless single adults at the Henry J. Robinson Multi Service Center (HRMSC) each year for Fiscal Year 2015-2016 and for 2016-2017, if City receives SSA funding; and

WHEREAS, funds will be deposited and appropriated in Fund 2160, Project H80610; and

WHEREAS, the City uses \$17,167 of the SSA grant funds to comply with administration and reporting requirements set forth in the SSA grant agreement; and

WHEREAS, staff is requesting a contribution from the general purpose fund in an amount equivalent to the Department's Central Services Overhead in an estimated amount of \$759 each year for Fiscal Year 2015-2016 and 2016-2017; now, therefore, be it

RESOLVED: That the City Administrator is hereby authorized to enter into an agreement with Alameda County SSA to accept and appropriate SSA funds in the amount of \$286,110 each year for Fiscal Years 2015-2016 and 2016-2017, and to increase or reduce these appropriations depending on the exact SSA award without returning to Council; and be it

FURTHER RESOLVED: That the funds will be deposited in Fund 2160, Project H80610; and be it

FURTHER RESOLVED: That the City will use \$17,167 of the SSA grant funds to satisfy administration and reporting requirements set forth in the SSA grant agreement; and be it

FURTHER RESOLVED: That the City Administrator or his designee is hereby authorized to enter into grant agreements with Bay Area Community Services in an amount not to exceed \$268,943 for transitional housing and support services at the HRMSC each year for Fiscal Year 2015-2016 and for Fiscal Year2016-2017, if City receives SSA funding; and be it

FURTHER RESOLVED: That the City Council herby authorizes a contribution from the General Purpose Fund in an amount equivalent to the Department's Central Services Overhead in an estimated amount of \$759 each year for Fiscal Year 2015-2016 and 2016-2017; and be it

FURTHER RESOLVED: That the City Administrator or his designee is hereby authorized to negotiate, submit and execute all documents, including, but not limited to, applications, contracts, grant agreements, amendments, payment requests, reports, and related actions for the completion of this program for Fiscal Years 2015-2016 and 2016-2017 without returning to Council; and be it,

FURTHER RESOLVED: That the above agreements shall be reviewed and approved by the Office of the City Attorney for form and legality and placed on file in the Office of the City Clerk.
