On July 18, 2006 pursuant to Resolution No. 80058 C.M.S., the City Council ordered formation of the Oakland Area Geologic Hazard Abatement District (GHAD) and appointed itself to act as the Board of Directors of the GHAD (GHAD Board). The Oakland Area GHAD Board met on October 3, 2006 and November 21, 2006 and adopted numerous resolutions to make the GHAD operational. GHAD Resolution No. 8, adopted on July 21, 2011, appointed Desley Brooks as the GHAD Chair.
