President Gibson-McElhaney and Members of the City Council:

Pursuant to Section 401 of the City Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances settlement is recommended in the sum of Sixty Thousand Dollars and No Cents (\$60,000.00) payable to Plaintiff Linda D. Ruano and her attorney James Paul Green.

This action arises from an incident on January 21, 2013, wherein Ms. Ruano tripped and fell on a city sidewalk adjacent to Alta Bates Summit Medical Center located at 3100 Summit Street in Oakland. Mr. Raines suffered a ruptured achilles tendon in her left leg, requiring surgery and ongoing medical treatment.

The Council authorized settlement of this case in Closed Session on Tuesday, June 2, 2015 (moved by Councilmember Kaplan and seconded by Councilmember Kalb – 8 Ayes).

WHEREAS, In order to avoid the risk of an adverse jury verdict under the circumstances; now therefore, be it

RESOLVED: That the City Attorney is authorized and directed to compromise and settle the case of <u>Linda D. Ruano v. City of Oakland, et al</u>, RG13-692524, City Attorney's File No. 29632, for the sum of Sixty Thousand Dollars and No Cents (\$60,000.00); and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement; and be it

FURTHER RESOLVED: That the sum of Sixty Thousand Dollars and No Cents (\$60,000.00) be payable to Plaintiff Linda Ruano and her attorney James Paul Green.
