RECOMMENDATION

Staff recommends that the City Council conduct a public hearing and adopt:

A Resolution Declaring Results Of Majority Protest Proceedings And Establishing The Oakland Tourism Business Improvement District 2015

REASON FOR SUPPLEMENTAL

On July 7, 2015 a public hearing, originally scheduled for April 21, 2015, was held regarding the proposed formation of an Oakland Tourism Business Improvement District 2015 ("OTBID"). The above public hearing was to satisfy the public meeting requirement of the proposed OTBID pursuant to California Streets and Highways Code Section 36623 and Government Code Section 54954.6.

At the above public hearing, representatives of Visit Oakland (OTBID's proposed Owners' Association), proposed the following changes to the OTBID, based on recent discussions with owners of affected lodging businesses:

- 1. Instead of a five-year term, the OTBID would have a three-year term;
- 2. Instead of \$2.50 per occupancy per night, the OTBID assessment would be \$1.50 per occupancy per night; and
- 3. Instead of including lodging businesses with eight or more rooms, the OTBID assessment would only apply to lodging businesses with 50 rooms or more.

Since the above public hearing was noticed as a non-action item only, any actions by City Council on the above proposed changes to the OTBID will occur at a second related public hearing, currently scheduled and noticed to take place on July 21, 2015.

At the July 21, 2015 public hearing, if a majority protest is not established (businesses that would pay fifty percent (50%) or more of the assessed value file protests against formation of the OTBID), California Streets and Highways Code permits City Council to pass a resolution establishing the OTBID. Streets and Highways Code Section 36624 limits the types of modifications that Council may propose, stating:

At the conclusion of the public hearing to establish the district, the city council may adopt, revise, change, reduce, or modify the proposed assessment or the type or types of improvements, maintenance, and activities to be funded with the revenues from the assessments. Proposed assessments may only be revised by reducing any or all of them. At the public hearing, the city council may only make changes in, to, or from the boundaries of the proposed property and business improvement district that will exclude territory that will not benefit from the proposed improvements or activities. Any modifications, revisions, reductions, or changes to the proposed assessment district shall be reflected in the notice and map recorded pursuant to Section 36627.

It is estimated that the above proposed changes to the OTBID, if adopted by City Council on July 21, 2015, will result in the following:

- 1. Instead of including approximately 71 lodging businesses, the OTBID will include approximately 29 hotels and motels (see *Attachment A* to this report).
- 2. Instead of generating approximately \$3,400,00 in assessment revenues per year, the OTBID will generate approximately \$1,623,611 in assessment revenues per year. The percentage of funds allocated to each spending category will remain the same as previously proposed (see *Attachment B* to this report).
