## INTRODUCED BY COUNCILMEMBER LYNETTE GIBSON MCELHANEY

RESOLUTION AUTHORIZING A GRANT OF \$600 FROM COUNCIL PRESIDENT LYNETTE GIBSON MCELHANEY'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO EAST BAY ASIAN LOCAL DEVELOPMENT CORPORATION, AS FISCAL SPONSOR FOR OLD OAKLAND NEIGHBORS, FOR A MOSAIC TRASH CAN PROJECT AT  $7^{\text{TH}}$  AND WASHINGTON STREETS

**WHEREAS,** on June 27, 2013, the City Council adopted a budget that set aside Anti-Graffiti Funds for Murals and Green Walls for the Oakland City Councilmembers to award at their discretion, subject to Council approval, in an effort to address graffiti within their districts; and

**WHEREAS**, any expenditures for purposes other than City or other governmental infrastructure, furniture, or equipment require council approval; and

**WHEREAS**, the City-owned trash can on 7<sup>th</sup> Street and Washington Street is often tagged with graffiti; and

**WHEREAS**, East Bay Asian Local Development Corporation is 501c3 non-profit comprised of community organizers and community builders that serve Oakland and the greater East Bay, particularly Asian and Pacific Islander communities to build healthy, vibrant, and safe neighborhoods through community development; and

**WHEREAS**, East Bay Asian Local Development Corporation is the fiscal agent for Old Oakland Neighbors, who will develop a mosaic on the trash can at 7<sup>th</sup> and Washington as part of a community-wide project to beautify the Old Oakland neighborhood; and

**WHEREAS**, Old Oakland Neighbors will participate in the City's Adopt-A-Spot program in which they will commit to maintaining the trash can following the installation of the mosaic upon trash can; and

**WHEREAS**, Council President Lynette Gibson McElhaney wishes to grant a portion of her Anti-Graffiti Mural and Green Wall Funds to the East Bay Asian Local Development Corporation as the fiscal agent for Old Oakland Neighbors to fund a mosaic on the exterior of the trashcan located on the corner of 7<sup>th</sup> Street and Washington Street in Old Oakland; and

WHEREAS, in conformance with City requirements, East Bay Asian Local Development Corporation and Old Oakland Neighbors will provide documentation for the use of the Councilmember's Graffiti Abatement Mural and Green Wall Funds, including any permits required and permission from the property owner to install this mural; now, therefore, be it

**RESOLVED:** That the City Council authorizes the grant of \$600 from Councilmember Lynette Gibson McElhaney's Graffiti Abatement Mural and Green Wall funds to the East Bay Asian Local Development Corporation as the fiscal agent for Old Oakland Neighbors for a mosaic trash can project at 7<sup>th</sup> Street and Washington Street in Oakland; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to execute a grant agreement with East Bay Asian Local Development Corporation, as fiscal sponsor for Old Oakland Neighbors, for the above purpose, subject to approval as to form and legality by the City Attorney.
