A RESOLUTION APPROVING THE MAYOR'S DESIGNATION OF THE ASSISTANT CITY ADMINISTRATOR OF THE CITY OF OAKLAND TO SERVE IN THE MAYOR'S PLACE AND STEAD AS A MEMBER OF THE POLICE AND FIRE RETIREMENT BOARD, EFFECTIVE AUGUST 1, 2015

WHEREAS, City Charter Article XXVI establishes the Police and Fire Retirement Board to manage and administer the Police and Fire Retirement System which oversees System fund investments and determines benefits for certain retired sworn police and fire personnel; and

**WHEREAS**, Section 2601 of the City Charter provides that the Police and Fire Retirement System shall be managed and administered by a Police and Fire Retirement Board; and

WHEREAS, Section 2601 of the City Charter further provides that the Mayor of the City of Oakland shall serve as one of the seven members on the Police and Fire Retirement Board; and

WHEREAS, Section 2601 permits the Mayor, with the approval of the City Council, to designate a City officer or official to serve in the Mayor place and stead as a member of the Police and Fire Retirement Board for the Term of the Mayor's office; and

**WHEREAS**, The Mayor designates the Assistant City Administrator to serve in the Mayor's place and stead, effective August 1, 2015, as a member of the Police and Fire Retirement Board for the balance of the Mayor's term; and

**WHEREAS**, pursuant to this change, the Mayor wishes to repeal Resolution No. 85380 C.M.S., which designated the City Controller to serve in the Mayor's place and stead as a member of the Police and Fire Retirement Board; now, therefore, be it

**RESOLVED**, that Resolution No. 85380 C.M.S. is repealed effective August 1, 2015 at 12:00 midnight, and be it

**FURTHER RESOLVED**, that the City Council approves the Mayor's designation of the Assistant City Administrator effective on August 1, 2015 at 12:00 midnight, to serve in the Mayor's place and stead as a member of the Oakland Police and Fire Retirement Board, and be it **FURTHER RESOLVED**, that the Assistant City Administrator shall serve as the Mayor's designee for the balance of her four-year term which commenced on January 5, 2015.
