RESOLUTION HONORING THE 2014-2015 BISHOP O'DOWD HIGH SCHOOL GIRLS BASKETBALL TEAM FOR CAPTURING THE DIVISION III (OPEN DIVISION) TITLE CHAMPIONSHIP FOR THE STATE OF CALIFORNIA
