RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO AWARD A CONTRACT TO GENERAL AUTO PARTS COMPANY, THE LOWEST RESPONSIBLE, RESPONSIVE BIDDER, A CORPORATION, IN AN ANNUAL AMOUNT NOT TO EXCEED FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00) TO PROVIDE AFTERMARKET AUTOMOTIVE PARTS & ACCESSORIES FOR A THREE YEAR TERM, AUGUST 1, 2015 TO JULY 31, 2018 FOR A TOTAL NOT TO EXCEED CONTRACT AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND DOLLARS (\$1,500,000.00), IN ACCORDANCE WITH SPECIFICATION NO. 15-465-14-01/REQUEST FOR QUOTATION (RFQ) NO. 5466, AND THE GENERAL CONDITIONS THEREFOR ON FILE IN PURCHASING SECTION AND CONTRACTOR'S BID FILED WITH THE CITY ON JUNE 1, 2015.

**WHEREAS**, on April 15, 2015, the City issued and advertised Specification No. 15-465-14-01/RFQ No. 5466 to provide aftermarket automotive parts & accessories; and

**WHEREAS,** on June 1, 2015, the City Clerk received and opened two bids in response to Specification No. 15-465-14-01/RFQ No. 5466 to provide aftermarket automotive parts & accessories; and

**WHEREAS**, the bids submitted by General Auto Parts, the lowest responsible, responsive bidder, a corporation, was deemed by the evaluation committee to be the lowest responder to Specification No. 15-465-14-01/RFQ No. 5466; and

WHEREAS, funds are available in the Equipment Fund (4100), Equipment Services Administration Organization (30541), Service Contracts for Machinery and Equipment Account (54612), Undetermined Project (0000000), Fleet Management and Maintenance (IN01); now be it

**RESOLVED:** That a contract to provide aftermarket automotive parts & accessories be awarded to General Auto Parts, the lowest responsible, responsive bidder, in an annual amount not to exceed five hundred thousand, dollars (\$500,000) for a three-year term from August 1, 2015 to July 31, 2018 for a total not to exceed contract amount of one million five hundred thousand dollars (\$1,500,000) in accordance with Specification No. 15-465-14-01/RFQ No. 5466 and the general conditions therefore on file with Purchasing according to its bids submitted on June 1, 2015, and authorize the City Administrator to approve two 1 year extensions for five hundred thousand, dollars (\$500,000) per year; and be it

**FURTHER RESOLVED,** That the City Council hereby rejects all other bids submitted in response to RFQ No. 5466; and be it

**FURTHER RESOLVED,** That the contract shall be approved for form and legality by the City Attorney and copies shall be on file in the City Clerk's Office.
