The Planning & Building Department (PBD) is responding to the following requests, following the October 27, 2015 Finance and Management Committee discussion:

#### Refunds to Appellants that Win their Cases

The annual loss in revenue per year is estimated to be approximately \$1,619.00 to \$1,887.00. If the City Council would like to authorize refunds to appellants that win their Appeal cases, a motion is required in order to amend the Master Fee Ordinance. PBD will work with City Administration and the City Attorney's Office to develop a procedure.

# Reduce Appeal Report Filing fee to Planning Commission to \$890.00 and Reduce Appeal Notification Fee to \$524.00

Both appeal fees are being lowered due to constituent complaints to City Council. Please note that the newly proposed fees will not be cost covering. All appeals include both a Report Filing fee plus a Notification fee. In addition, there is a 14.5% Recordation and Technology fee that is applied to all base fees.

WHEREAS, City staff in the Office of the City Attorney, Office of the City Clerk, Office of the City Auditor, Oakland Public Works, Housing and Community Development, the Revenue Management Bureau, Human Resources Department, and Planning and Building Department ("the Departments"), undertook analysis and evaluation of the revenue requirements to fund ongoing municipal services, programs and activities and the fee structure necessary to proportionately allocate the costs of providing these government services and programs; and

WHEREAS, the Agenda Report including Attachments A-1, A-2, A-3, A-4, A-5, A-6, A-7, and A-8, and B (herein "the Agenda Report") dated, October 1, 2015, provided by staff of the Departments in support of the amendments to this ordinance, was prepared for fee revisions and deletions for continuing to provide the various government services; and

WHEREAS, the investigations conducted by staff of the Departments reflected in the Agenda Report show that existing revenues are and will be insufficient to cover the current and projected costs of operating and maintaining identified City government activities, services and programs; and

WHEREAS, the fee modifications and additions proposed by the Departments, and the facts and analysis in support thereof are identified in the Agenda Report; and


