RESOLUTION AUTHORIZING COUNCILMEMBER DAN KALB'S TRAVEL TO LOS ANGELES FOR ATTENDANCE AT THE U.S.-CHINA CITIES CLIMATE LEADERS SUMMIT ON SEPTEMBER 16, 2015 AND REIMBURSEMENT OF APPROXIMATELY \$750.00 IN TRAVEL COSTS FROM HIS OFFICE ACCOUNT

WHEREAS, Councilmember Dan Kalb attended the U.S.-China Cities Climate Leaders Summit in Los Angeles, CA on September 16, 2015; and

WHEREAS, Mayor Libby Schaaf requested that Councilmember Kalb attend the U.S.-China Climate Leaders Summit to represent the City of Oakland since she was not able to attend; and

WHEREAS, the U.S.-China Climate Leaders Summit fulfilled a key element of the U.S.-China Joint Announcement on Climate Change by Presidents Barack Obama and Xi Jinpeng last November, helped to ensure that the ambitious actions to address climate change that both leaders committed to will be implemented at the state and local level, and included participation by cities, counties and states of the United States and cities and provinces of China, which allowed Councilmember Kalb to participate as Oakland's representative including meeting with Vice President Joe Biden; and

WHEREAS, City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010 establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used as well as the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost for Councilmember Kalb's travel is \$452 for airfare, \$226.87 for one night of lodging, and \$59.55 for ground transportation; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from Councilmember Kalb's existing office budget; and

WHEREAS, Councilmembers Dan Kalb seeks Council approval of the fore mentioned estimated costs; now, therefore, be it
