RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO AWARD A CONTRACT TO LC ACTION POLICE SUPPLY, THE LOWEST RESPONSIBLE, RESPONSIVE BIDDER, A CORPORATION, TO PROVIDE REMINGTON SHOTGUNS AND ACCESSORIES, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY-SEVEN THOUSAND ONE HUNDRED NINETY- FIVE DOLLARS AND TWENTY CENTS (\$127,195.20) PER REQUEST FOR QUOTATION (RFQ) NO. 5608, SPECIFICATION NO. 15-680-52 AND THE GENERAL CONDITIONS THEREFOR ON FILE IN THE PURCHASING SECTION ACCORDING TO ITS BID FILED WITH THE CITY ON JUNE 29, 2015.

WHEREAS, the bids submitted by LC Action Police Supply, the lowest responsible, responsive bidder, a corporation, was deemed by the evaluation committee to be the lowest responder to Specification No. 15-680-52/RFQ No. 5608; and

WHEREAS, funds are available in the General Purpose Fund (1010), District Command Administration Organization (108010), Supplies Technical and Scientific Account (52913), Undetermined Project (0000000), Community Oriented Policing Services Program (COPS) and; now be it

RESOLVED: That the City Council authorizes the City Administrator to enter into a contract with LC Action Police Supply, the lowest responsible, responsive bidder to purchase Remington Shotguns and Accessories, in an amount not to exceed one hundred twenty-seven thousand one hundred ninety-five dollars and twenty cents (\$127,195.20) in accordance with Specification No. 15-680-52/RFQ No. 5608 and the general conditions therefor on file with Purchasing according to its bids submitted on June 30, 2015; and be it

FURTHER RESOLVED: That the City Council hereby rejects all other bids submitted in response to RFQ No. 5608; and be it
