RESOLUTION **AUTHORIZING** \$2,000 Α GRANT OF **FROM** COUNCILMEMBER CAMPBELL WASHINGTON'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS MONTCLAIR VILLAGE ASSOCIATION FOR A MURAL ON OAKLAND UNIFIED SCHOOL DISTRICT PROPERTY AT 2400 MOUNTAIN **BOULEVARD IN OAKLAND**

WHEREAS, on June 27, 2013, the City Council adopted a budget that set aside graffiti abatement funds for murals and green walls in the amount of \$50,000 for each council member to use in order to address graffiti within their districts, subject to Council approval; and

WHEREAS, the wall at 2400 Mountain Boulevard is owned by the Oakland Unified School District ("OUSD") and is currently in a state of graffiti blight; and

WHEREAS, Councilmember Campbell Washington wishes to grant a portion of her Graffiti Abatement Mural and Green Wall Funds to the Montclair Village Association for the mural at 2400 Mountain Boulevard to beautify the culturally rich neighborhood, as well as to abate and deter graffiti; and

WHEREAS, in conformance with City requirements the Montclair Village Association will provide documentation for the use of the Councilmembers Graffiti Abatement Mural and Green Wall funds, including any permits required and permission from the property owner OUSD of the proposed mural site; now, therefore, be it

RESOLVED, that the City Council authorizes a grant not to exceed \$2,000 from Councilmember Campbell Washington's Graffiti Abatement Mural and Green Wall funds to the Montclair Village Association for the mural at 2400 Mountain Boulevard; and be it

FURTHER RESOLVED, that the City Administrator is authorized to execute a grant agreement with the Montclair Village Association in the amount of \$2,000 for the above purpose, subject to approval as to form and legality by the City Attorney.
