

#### RECOMMENDATION

Staff Recommends That The City Council Adopt A Resolution Renaming the Golden Gate Recreation Center To The Charles Porter Golden Gate Recreation Center.

#### EXECUTIVE SUMMARY

Adoption of the proposed resolution will authorize the renaming of the Golden Gate Recreation Center after long time Oakland resident and local community activist, Charles Porter. Charles Porter passed away on January 12, 2013, leaving a lasting legacy of his sincere dedication to Oakland and the Golden Gate community.

#### BACKGROUND / LEGISLATIVE HISTORY

Oakland Parks and Recreation staff received numerous requests from local community members to rename the recreation center after Charles Porter. The policy to name a public facility is set forth in Resolution No. 65024 C.M.S., and requires that all requests for naming or renaming parks and recreation facilities be referred to the Parks and Recreation Advisory Commission (PRAC) and the Rules & Legislation Committee before the name is recommended to the City Council. Resolution No. 65024 C.M.S. states that "facilities named for a specific individual should rarely be renamed, although the City Council could be flexible in renaming facilities originally named for geographical areas." On May 13, 2015 PRAC unanimously recommended the renaming of the Golden Gate Recreation Center to the "Charles Porter Golden Gate Recreation Center".

Charles Porter often spoke about upgrading the recreation center to make it more accessible and welcoming. Charles regularly attended and spoke at community meetings with the project architects as well as the project manager about community concerns and his vision of the center and how it would best benefit the community. Mr. Porter worked very hard with the Golden Gate Recreation Center staff, Neighborhood Crime Prevention Council (NCPC), and the project committee until he became ill. Even during his illness, Mr. Porter often called the center director to be kept updated on how the project was moving along and if there was anything he could do

Mr. Porter also coordinated the "North Oakland National Night Out" block party which featured the Golden Gate Recreation Center project. Mr. Porter made sure the Golden Gate Renovation project remained front and center in local residents' minds.

#### ANALYSIS AND POLICY ALTERNATIVES

Charles Porter was one of the first black families to move into the Golden Gate neighborhood in 1946. Mr. Porter was a Community Development Block Grant (CDBG) board member, and founder of the Neighborhood Crime Prevention Council Beat 10x (North Oakland Community) that met once a month at Golden Gate Recreation Center. Charles Porter also served as a member of the Golden Gate Recreation Center Advisory Board where he advocated for programs and activities that would meet the needs of the community. Mr. Porter worked diligently with the advisory board, staff, and the community in efforts to build a new facility with a gymnasium, a request of the local youth Mr. Porter took to heart. Mr. Porter sat on the project committee that was interviewed by the State of California Grant Office Officials, in order to select a site to allocate funds. In addition, Mr. Porter advocated on behalf of the Golden Gate and how the building needed to be upgraded to provide a 'state of the art' recreation center, allowing for more programs and activities to be offered to the community such as: cooking classes, computer lab, performing arts, sports, arts and crafts, and fitness programs.

In January 2016, after years of teamwork and struggle, the new "Golden Gate Recreation Center" will reopen, featuring a gymnasium for local youth and families, just like Mr. Porter championed for so long.

Due to Mr. Porter's exemplary dedication to the Golden Gate Community and recreation center and overwhelming support for this name change, staff recommends renaming the Golden Gate Recreation Center the Charles Porter Golden Gate Recreation Center.

#### FISCAL IMPACT

There is no fiscal impact to the City of Oakland in renaming this center.

#### **PUBLIC OUTREACH / INTEREST**

In addition to discussion at Neighborhood Crime Prevention Council (NCPC) and community meetings, staff received numerous requests from local community members to rename the park after Charles Porter. This item was discussed at the May 13, 2015 PRAC meeting. PRAC received a proposal from staff and community members to rename the Golden Gate Recreation Center and recommended approval by the Oakland City Council.
