President Reid and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of the resolution authorizing compromise and settlement of the above-entitled claim for the sum of One Hundred and Fifty Thousand Dollars (\$150,000.00), to be paid to the "Law Offices of Scott A. Bonzell Client Trust Account for Joan Zeremariam and Solomon Zeremariam".

This matter arises from a trip and fall on a sewer line cleanout in the sidewalk on the north side of Enos Avenue and alongside the property address of 4643 Tulip Avenue on September 12, 2014. Ms. Zeremariam, then age eight-two years old, suffered left femoral and humeral fractures.

The Council authorized settlement of this case in Closed Session on Tuesday, December 8, 2015 (moved by Councilmember Noel Gallo and seconded by Councilmember Campbell-Washington – 8 Ayes).

**WHEREAS**, Plaintiff Solomon Zeremariam alleges emotional distress from witnessing the trip and fall; and

WHEREAS, Plaintiffs filed the above referenced action to recover monetary damages; and

**WHEREAS**, without admitting fault or wrongdoing, the City has determined to compromise and settle Plaintiffs' claims against it for the sum of One Hundred and Fifty Thousand Dollars and No Cents (\$150,000.00); now, therefore, be it

**RESOLVED:** That the City Attorney is authorized and directed to compromise and settle the case of <u>Joan Zeremariam</u>, et al. v. City of Oakland, Alameda County Superior Court Case No. RG15767845, City Attorney's File No. 30286, for a sum not to exceed One Hundred and Fifty Thousand Dollars and No Cents (\$150,000.00) payable by the City of Oakland; and be it

**FURTHER RESOLVED:** That the City Attorney is further authorized and directed to take whatever steps necessary to effect said settlement; and be it
