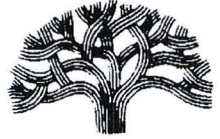



RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CASE OF ANTONIO TILLIS v. CITY OF OAKLAND, ALAMEDA COUNTY SUPERIOR COURT CASE NO. RG12645745 CITY ATTORNEY'S FILE NO. 29024, IN THE AMOUNT OF FOUR HUNDRED FIFTY THOUSAND DOLLARS AND NO CENTS (\$450,000.00) (OAKLAND PUBLIC WORKS - DANGEROUS CONDITION)

WHEREAS, Antonio Tillis alleges that he incurred damages as a result of an injury that he sustained due to the condition of a public property; and

WHEREAS, Antonio Tillis, filed a personal-injury lawsuit against the City; and

WHEREAS, without admitting fault or wrongdoing, the City has determined to compromise and settle Antonio Tillis's claims against it for the sum of Four Hundred Fifty Thousand Dollars and No Cents (\$450,000.00) payable by the City of Oakland; now, therefore, be it

RESOLVED: That the City of Oakland is authorized and directed to compromise and settle the case of Antonio Tillis v. City of Oakland, Alameda County Superior Court Case No. RG12645745, City Attorney's File No. 29024, for a sum not to exceed Four Hundred Fifty Thousand Dollars and No Cents (\$450,000.00); and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps necessary to effect said settlement; and be it

FURTHER RESOLVED: That the sum of Four Hundred Fifty Thousand Dollars and No Cents (\$450,000.00) be paid to Antonio Tillis.
