#### RECOMMENDATION

Staff Recommends That The City Council:

Adopt A Resolution: 1) Authorizing The City Administrator, Or Designee, To Purchase: (A) Body Worn Cameras For Forty-Five Thousand Dollars (\$45,000) And Hardware For Eighteen Thousand Five-Hundred Dollars (\$18,500), For A Total Cost Not To Exceed Sixty Three Thousand Five Hundred Dollars (\$63,500) From Adamson Police Products; And (B) Technical Support For One Hundred Thousand Dollars (\$100,000) from VIEVU; And 2) Waiving The City's Advertising / Bidding Requirements And Request For Proposal For The Proposed Purchases.

#### REASON FOR THE SUPPLEMENTAL REPORT

The Public Safety Committee on March 22, 2016 requested that OPD provide additional information regarding the necessity of purchasing additional body worn cameras (BWC) before a Request for Proposals/Request for Qualifications (RFP/Q) process is initiated, which would lead to OPD purchasing a new fleet of BWCs and related technology. Additionally, during the Committee meeting, representatives from TASER International offered to provide free BWCs to OPD. The Committee requested that OPD evaluate whether it would be possible to receive free cameras from TASER, and how they could be configured to function with OPD's current BWC fleet.

#### ANALYSIS AND POLICY ALTERNATIVES

The "Purchase of Additional Body Worn Cameras Report," dated December 31, 2015 explains the importance of maintaining a fleet of functioning BWCs for all sworn personnel assigned to field work. The "Purchase of Additional Body Worn Cameras Supplemental Report," dated March 14, 2016 explains that OPD is currently preparing to issue a RFP/Q to replace its aging fleet of 546 BWCs and related technology. The report details the timeline for the RFP/Q process. This supplemental report explains that OPD needs 50 additional BWCs as well as

Item: \_\_\_\_\_ Public Safety Committee April 12, 2016 associated hardware to provide BWCs to new officers in the immediate term. The report also explains that OPD needs an ongoing maintenance contract as repairs are constantly needed.

#### BWC Maintenance

This second supplemental report provides a proposed resolution for consideration (*Attachment A*). In this resolution, the requested spending authority for short-term maintenance funding has been reduced from \$200,000 to \$100,000. OPD is requesting a lower amount due to the shorter period before which a new BWC fleet will be deployed. OPD will have a new ongoing maintenance program as part of the purchase of new BWCs, once the RFP/Q process is complete.

#### Purchasing Additional BWCs before a new RFP/Q Process is Complete

The "Purchase of Additional Body Worn Cameras Supplemental Report," dated March 14, 2016 and presented to the Public Safety Committee on March 22, 2016, requested spending authority for 50 additional BWCs along with 100 Universal Serial Bus (USB) vehicle plugs, and 10 docking stations. The report explains that this purchase would be necessary for OPD to equip additional officers (currently in the basic academy) with BWCs. The accompanying resolution with this report contained the correct funding amounts in the title (\$263,500), but contained an incorrect numerical total in the body of the resolution (\$717,000). *Attachment A* is a draft-corrected version of this resolution – but now with the lower requested maintenance spending authority of \$100,000, and with the changes shown in cross-out, bold and italics.

The "Purchase of Additional Body Worn Cameras Supplemental Report," dated March 14, 2016 explains that only officers in units primarily assigned to field work have BWCs, as OPD does not currently have enough BWCs to actually equip every single sworn officer. BWCs are assigned to all of the following OPD divisions according to OPD BWC policy:

- Office of the Chief (Chief and Assistant Chief)
- All patrol division officers, sergeants, lieutenants and captains
- Community Resource Officers (CRO) and sergeants,
- Support Operations Division
- Traffic Section
- Foot Patrol
- Criminal Investigation Division (CID)'s Youth and School Services Section
- Special Investigation Units

In total, approximately 491 functioning BWCs currently need to be deployed to these sworn personnel. Currently, approximately 20 BWCs are being repaired due to damage. OPD recommends having a BWC reserve of 10 percent so that new cameras can be immediately issued when damage inevitably occurs. OPD has a current fleet of 546 cameras – OPD currently provides BWCs to the personnel listed above. However, OPD will soon have more sworn officers in the department as current Police Officer Trainees (POTs) in current academies graduate and enter the force. OPD will not have sufficient BWCs to staff every new officer and maintain a needed reserve as cameras are repaired.

#### Accepting BWCs from TASER International before OPD completes the RFP/Q Process

TASER International representatives at the March 22, 2016 Public Safety Committee explained that TASER plans to bid in OPD's upcoming BWC RFP/Q process. During their presentation they explained that they would also be willing to furnish OPD with 50 free TASER-manufactured BWCs. OPD has since spoken with the City's Contract Compliance Department to discuss whether it would be appropriate for OPD to receive free cameras from a firm that wishes to bid in a competitive contract. Contract Compliance staff explained that the City would be providing an unfair competitive advantage to a firm that wishes to bid on a competitive City contract by testing or evaluating new cameras from that firm. Additionally, OPD would likely need to enter into a Non-disclosure Agreement (NDA) with a firm to receive a gift of technology in the context of an upcoming RFP/Q. Furthermore, OPD has reason to believe that VIEVU, the current provider of OPD's BWCs, would need to provide a significant amount of proprietary technology to TASER International - its competitor in this market place - for the TASER BWCs to function effectively with OPD's current system. The addition of new BWCs from a different manufacturer may also lead to other technological complications. Therefore, staff does not believe that it is in the City's interest to receive additional cameras from a different vendor prior to the competitive RFP/Q process.

There will be a testing phase/trial period for different vendors included in the formal BWC RFP/Q process conducted by OPD.

WHEREAS, the City Administrator has determined that the contract with VIEVU is of a professional and temporary nature and shall not result in the loss of employment or salary by any person having permanent status in the competitive civil service; now, therefore, be it

**RESOLVED:** That the Oakland City Council, hereby authorizes the City Administrator, or designee, to purchase body worn cameras <u>for forty-five thousand</u> <u>dollars (\$45,000)</u> and hardware <u>for eighteen thousand five hundred dollars (\$18,500)</u> from Adamson Police Products for a cost not to exceed three hundred ninety four thousand five hundred dollars (\$394,500) sixty three thousand five hundred dollars (\$63,500); and be it

**FURTHER RESOLVED:** That pursuant to OMC 2.04.050.1.5 and the for the reasons stated above and in the City Administrator's report accompanying this item, the City Council finds that it is in the best interests of the City to waive advertising and bidding requirements for the purchase BWCs and hardware from Adamson Police Products and so waives the requirements; and be it

**FURTHER RESOLVED:** That the Oakland City Council, hereby authorizes the City Administrator, or designee to purchase software for seventy thousand dollars (\$70,000), storage for forty seven thousand dollars (\$47,000), and technical support from VIEVU for <u>onetwo</u> hundred thousand dollars (\$<u>1</u>200,000) per year for Fiscal Years 2015-16, 2016-17, and 2017-18, for a total cost not to exceed seven hundred and seventeen thousand dollars (\$717,000); and be it

FURTHER RESOLVED: That the total cost authorized for the aforementioned purchases and services to be provided by Adamson Police Products and VIEVU are not to **FURTHER RESOLVED:** That pursuant to OMC sections 2.04.051.B and 2.04.050.I.5, for the reasons stated above and in the City Administrator's report accompanying this item, the City Council finds that it is in the best interests of the City to waive the advertising, bidding, and Request for Proposals/Qualifications (RFP/Q) requirements for the contract with VIEVU to purchase software, storage, and technical support and so waives the requirements; and be it
