Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled claim for the sum of Thirteen Thousand One Hundred Ninety Nine Dollars and 30/100 Cents (\$13,199.30), made payable to Juan Carlos Pacheco.

This action arises out of a February 3, 2016 incident in which Mr. Pacheco claims property damage as a result of a collision with an OPD vehicle.


