WHEREAS, the Citizen's Police Review Board consists of nine members and three alternative members serving two-year staggered terms with no more than two consecutive terms; and

WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Mya Whitake, Howard Tevelson and Thomas Cameron to serve a two-year term on the Citizen's Police Review Board subject to confirmation by the City Council; now therefore be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's reappointment of:

Mya Whitaker to serve a two-year term on the Citizen's Police Review Board beginning February 16, 2016 and ending February 15, 2018, filling the seat previously held by herself; and

Howard Tevelson to serve a two-year term on the Citizen's Police Review Board beginning February 16, 2016 and ending February 15, 2018, filling the seat previously held by himself; and

Thomas Cameron to serve a two-year term on the Citizen's Police Review Board beginning February 16, 2016 and ending February 15, 2018, filling the seat previously held by himself.
